FINANCE COMMITTEE August 26, 2020

The meeting of the Finance Committee was called to order by Chair Harley Reabe on Wednesday, August 26, 2020 at 4:30 PM, in the County Board Room and via Zoom format at the Government Center, Green Lake, WI. The requirements of the open meeting law were certified as being met. The Pledge of Allegiance was recited.

MINUTES

Motion/second (Lenz/Abendroth) to approve the minutes of the July 22, 2020 meeting and the August 18, 2020 special meeting with no additions or corrections. Motion carried with no negative vote.

TREASURER'S MONTHLY REPORT

• Tax Collection Update

Treasurer Amanda Toney stated that 1.39% of the 2019 property taxes remain uncollected. This amounts to 479 parcels.

• July Financial Reports

No updates provided from written submitted report. No discussion.

• Sales Tax Update

Treasurer Amanda Toney stated that the sales tax figures are approximately \$100,000 above the July 2019 figures.

IN REM UPDATE

Treasurer Amanda Toney stated that uncollected taxes from 2016 are currently at 28 parcels (25 owners).

OPEN AND TAKE ACTION ON IN REM BIDS

Chair Reabe opened 3 sealed bids:

• Bid received from Kavanaugh Family LLC for 122 W. Main St., Princeton in the amount of \$5,000 with the full amount submitted in a cashier's check.

Motion/second (Mulder/Abendroth) to approve the bid of \$5,000 for the property. Discussion held. Pictures of the property provided by Treasurer Toney. Motion carried with no negative vote.

• Bid received from Michael Wilson for 125 Centre St., Marquette in the amount of \$3,500 with a personal check for \$350 (10%) down.

Motion/second (Floeter/Lenz) to approve the bid of \$3,500 for the property. Discussion held. Pictures of the property provided by Treasurer Toney. Motion carried with no negative vote.

2021 ECONOMIC DEVELOPMENT CORPORATION BUDGET

Lindsey Kemnitz, Chair of the EDC, handed out tourism reports from the Wisconsin Department of Tourism along with the social media reports for Green Lake Country Visitors Bureau (GLCVB) for all of 2019 and January through July of 2020. The proposed 2021 budget was presented at \$9,500. Kemnitz and Scott Mundro of GLCVB explained how the funding is used. The committee thanked both for the information provided.

BUDGET REVIEW

July revenues and expenditures were reviewed and discussed by the committee. Supervisor Floeter requested a consolidated report each month from the Financial Manager.

MEMO TO FINANCE COMMITTEE

The August sales tax deposit was \$171,355.64. At this point in the year, we are \$90,155.49 ahead in sales tax dollars compared to this time last year.

Total boat launch fees collected as of August 31, 2020 was \$52,892.73. This total is consistent with last year's figures.

Tax Collection Update

As of 8-31-20: We had \$551,885.49 left to collect, which was 1.31% of the total 2019 Real Estate taxes.

As of 8-31-19: We had \$480,638.00 left to collect, which was 1.16% of the total 2018 Real Estate taxes.

On the first business day of September, we issued a certificate number to every parcel with delinquent 2019 taxes. This year we mailed out 437 letters. The number of letters mailed this year is slightly higher when compared to last year. This "issuance" starts the redemption period until Green Lake County could take the property.

In-Rem Update

Below is a summary on the current parcels in the In-Rem process

Dawn filed a "Notice Of Commencement Of Proceeding In Rem To Foreclose Tax Liens By Green Lake County, Petition and List of Liens" with the Clerk of Circuit Courts on Monday September 14, 2020. This same list of properties and owners will run in the official county paper for three consecutive weeks starting on Thursday September 17th, 2020. The Treasurer's office is currently working on mailing out, via certified mail, a copy of the court filing as well as the section of the Exhibit which shows their exact property, to each property owner as directed by State Statute.

Per the September credit card statement, we have a balance of 2,199,592 credit card points. The county has earned an additional 31,007 points this statement. This calculates to \$21,995.92.

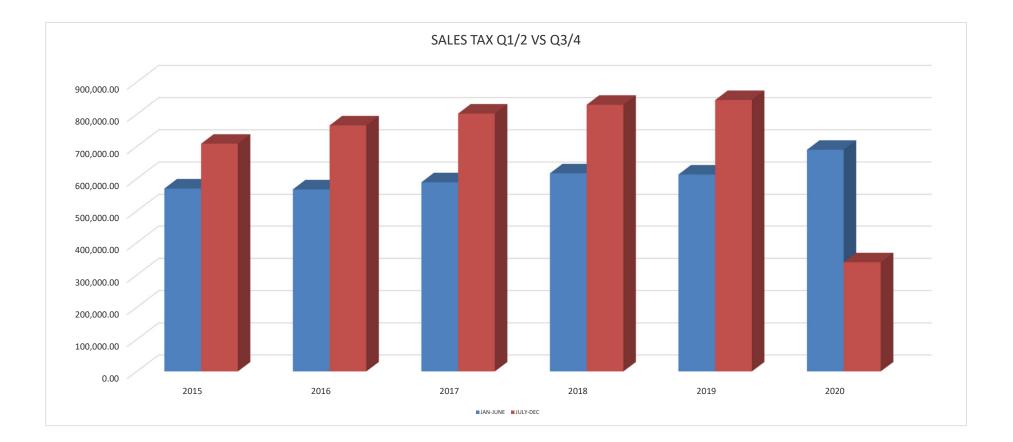
