#### September 2020 Green Lake County Library Reports

**Berlin –** With the end of summer (when did that happen?), we will begin our winter Saturday hours of 9am to 5pm beginning Saturday, September 12. We continue to offer full services to patrons with some restrictions. Luckily, we have not had to restrict too much due to patrons respecting our visiting guidelines. Most patrons are very appreciative of the services the library has to offer and are willing to follow the rules to have access to books, movies computers and other things in our library.

We have re-opened our meeting room to small group gatherings due to the requests we have been getting from organizations such as Christine Ann and various Green Lake County departments. Many are moving to face-to-face meetings to make handling situations easier. We are happy to help their need.

With school starting, our library has reached out to local teachers to offer assistance in gathering material for classrooms and homeschool parents. We know there are some who are not yet comfortable getting out in public places, so we are offering other ways of getting books in the kid's hands. We have also added delivery service within the city limits.

The Berlin Library has been offering Crafts-to-Go for adults and kids, in place of our in-library programs. They have all been very popular and are picked up quickly.

The Friends of the Berlin Library Book Sale will take place on September 17-19 in the mezzanine of the Berlin Library. The hours will be Thursday 5-7 pm, Friday 10 am-5 pm, and Saturday 9 am-12 pm. Come browse and buy from a huge selection of used books, DVDs, and other media. The best part? YOU pick the price. All sales will be goodwill donations. All proceeds support the library, which is especially important during this time. Face coverings are required to browse.

Join us Friday September 18 at 8 pm for our first ever outdoor movie! We will be showing the PG-rated family-friendly feature *Sing* in front of the old entrance of the Carnegie Library. Bring your own chairs and blankets and join us for popcorn and a show! Space is limited, please call the library at 920-361-5420 to register.

**Green Lake** – Back to school means saying goodbye to our summer residents and hello to a new rhythm of students and their needs. To comply with new school guidelines, we are going to attempt to modify our usual story times at school into a new and fun digital format for students to enjoy. This year continues to be full of changes, and with the kids going back to school along with the addition of a new staff member we are increasing our hours to include Saturdays starting September 12 from 9 am -1 pm. The library will be closed for Labor Day on Monday, September 7th. If you haven't seen the library lately, I encourage you to take a stroll by the library and read our new storyboards (pictured).

One of the best back-to-school items you can have is a library card and it just so happens that September is Library Card Sign-Up Month. Public libraries work with schoolteachers and librarians to provide curriculum support as well as pleasure reading materials for students. Databases provided through BadgerLink bring thousands of grade-appropriate articles to students. Libby, hoopla, and Mango Languages fill in even more entertainment and educational niches. Homeschooling families find all sorts of great educational books and movies at their local libraries. All that's needed to access these items is a free library card.

There were four book sales in August to work out all the new processes and safety measures to keep volunteers and shoppers safe. And there will be more sales to come! Although the Friends have decided to cancel the big Harvest Fest book sale, there will be another sale on Saturday, September 12 from 9 am to noon. We are also getting back to creating Activity Packs. We currently have another 8 weeks of crafts and activities planned! This fall will be a beautiful time to enjoy creating, learning, and hunting for some fun. We have a few packs out now to keep up with demand but will really get back into the weekly packs after Labor Day.

Our long-range planning committee has started to gather ideas for the next five years of library services, upgrades, hopes, and dreams. We would welcome any ideas you might have or those of community members. I'm available during regular business hours and also welcome emailed ideas at director@greenlakelibrary.org.

**Kingston –** Census workers sat out in front of the library last week, during the heat and storms, catching people walking by to help them fill out the form if they hadn't done so already. One library customer said when she came in the library, "If I had known how simple it was I would have done it right away."

Last month our display was for the collection of school supplies for the Markesan School District. Two large boxes of supplies were donated. This coming month the display will be for new books. The nights are getting longer, stop in and check out a good read.

**Markesan** – At the Markesan library we've witnessed the changes over the years that have made traditional literacy and digital literacy more and more important. With school starting back up and the special circumstances of COVID impacting our community, we wanted to provide a fun, interactive way to keep students reading and to encourage patrons of all ages to take advantage of our online resources. Therefore, along with 1,000 Books Before Kindergarten, we are working on a 100 Books Before College challenge and a Digital Doorways challenge using Beanstack. Again, Beanstack was brought to us by the **Wisconsin** Department of Public Instruction and is made possible in part by the Institute of Museum and Library Services grant LS-00-19-0050-19. It's a program where patrons earn badges for completing specific activities or logging time spent reading. Libraries can add to the fun by providing small prizes for reaching certain benchmarks or by entering participants into raffles. In all of Markesan's Beanstack challenges we will be offering small prizes and incentives including free books.

We are also going to have a Haunted Wisconsin program on Monday, Septmember 26<sup>th</sup> with Chad Lewis. Chad Lewis has authored several books and usually draws a very nice crowd with great discussion. He is offering his program virtually, so we are going to try it through Facebook and Zoom. We are hopefully, that people will attend.

We are also offering make and take crafts again and book/craft kits for the kids. Right now, we are going to readdress when to start Storytime again at the next library board meeting. The consensus at the last board meeting was to wait and see what is working and what isn't in the school system first so when we do launch we can do so with confidence.

I also plan to attend the October Green Lake township meeting with Christina from Green Lake Library. We plan to present to the local board about all the services we have to offer people and to encourage library patronage.

Thank you for your continued support and please feel free to let me know if you have any library related questions, suggestions, or concerns.

**Princeton –** We have a new library board member, appointed by the Green Lake County Board, Crystal Marschall. She has already been a great help to us!

Our outdoor events are doing well, and we will continue to hold as many as is feasible with the weather. We were happy to support our local businesses and Chamber of Commerce by selling wine tickets for the Sip N Shop in Princeton this month. We also hosted live music for people on the street.

Building improvements/fixes continue—my office light was fixed, a rooftop control panel on the heating system swapped out, and our contractor is working on a quote to get a water spigot re-installed in the back yard.

There are going to be a lot of library cards expiring in September. Patrons will be required to show photo ID, and if the ID does not have the current address, proof of current address in the form of recently mailed documents. This is a yearly occurrence and gives us a chance to check that we have everyone's current information on file. We need to be able to send notices when a book has come in for people, or if one is very overdue. We also want to prevent identity theft.

We had a small incident this month where one patron wearing a mask angrily confronted another patron who was not wearing a mask, swearing and making accusations. So far this has been our only incident along those lines.

We are in the middle of the budget process for the City of Princeton. It's not yet known how badly the city will feel budget cuts from the county and state. The \$3,400 drop in library funding from the county will hurt us, but we know it could be worse.


Katie Gellings Green Lake County Health & Well-Being Extension Educator August 2020

This report briefly describes the work that was completed within the Health & Well-Being Institute in August of 2020. During the reporting period, the educator made 59 direct educational and professional contacts.

**Educational Programming, Networking and Outreach in the Local Community** 

United Migrant Opportunity Services (UMOS) Child Care Center – Summer Programming

For the past five summers, I have been providing programming for the UMOS child care centers in Green Lake County. During the month of August I provided four lessons to the youth at the UMOS Child Care Site via Zoom. Two of the lessons focused on nutrition and two focused on financial education. The first nutrition lesson we talked about MyPlate and read a story about Gregory who is a terrible eater. The youth participants drew pictures of their favorite foods in the correct food group and while they showed me their MyPlate pictures we discussed it in detail. During the second nutrition lesson we talked about trying new foods even if we might think we don't like them. We read a story and reviewed the MyPlate food groups. The participants got to try blueberries and green peppers, which most didn't think they would like and they ended up liking it! Then with the teacher's help the students made smoothies. The first financial lesson talked about saving money, and how even a little bit of savings will add up over time. We discussed safe places to keep money and the students got to decorate a plastic pouch to keep their savings money in. For the second lesson, we discussed needs and wants, and how sometimes we have to make choices with where our money has to be spent. It was definitely a challenge to program with this audience over the Zoom platform but I was glad to continue to meet the need and grow the partnership again this summer.



Green Lake County Food Pantry, Meals on Wheels, Senior Meal Site – Food Resources and Social Isolation Resource Guide

I have been working with Kathy Mulhern to distribute some resources that I have developed for the food pantry clients, as well as, those who utilize Meals on Wheels and Senior Meal Site services. I will continue to provide educational information on healthy food resource management, social isolation connections in Green Lake County, and stress management throughout the year.

#### **Networking within Extension and Professional Development Opportunities**

I made 18 contacts within the UW Extension system during the month of August. I continue to have a number of professional meetings scheduled with colleagues and mentors to continue to network and learn from my fellow Extension educators.

Healthy Schools Policy, Systems, and Environment (PSE) Workgroup
I am part of a healthy schools workgroup that focuses on implementing PSE work
within school systems. I specifically am looking at implementing Youth
Advocates for Community Health (YACH) within at least one Green Lake County
school and/or the Boys and Girls Club in either Berlin or Green Lake. YACH is a
program for high school students to gain hands-on experiences improving health at
the local level. A small group of youth will work as a team to identify strategies
and develop plans to address a community health issue they care about.

ADVOCATES FOR

Stress & Coping Workgroup

I am also part of a workgroup that is working on the creation of a wellness program that helps participants overcome

barriers to achieving wellness. Wellness encompasses many different areas in life and looks different for each individual. Increasing physical activity or building healthier eating habits or practicing daily meditation or gaining financial security are all examples of wellness. There are various barriers that one encounters while trying to reach a high level of wellness, and our workgroup is developing a program that sets participants up for success by breaking down the barriers. I am looking forward to implementing the completed program in Green Lake County.

Aging Mastery Program (AMP) Training and Implementation

If older adults spend just a bit of time each day taking better care of themselves, it will lead to higher levels of physical and emotional wellbeing, increased civic engagement and stronger social connectedness. This would strengthen our communities in many ways. AMP is a 10-week evidence-based program that is designed to help seniors get the skills and tools needed to achieve measurable improvements in managing health, remaining economically secure, and contributing actively to society. I was recently trained at no cost to teach AMP in Green Lake County with the requirement to teach at least twice (virtual requirement) before December of 2021. It generally costs about \$60 for each participant to take the course but under the grant funding period participants will be able to take the class free of charge. I am working with the ADRC Coordinator and ADRC Unit Manager to set up a plan to offer AMP in the next few months.



This report briefly describes the work that was completed within the Agricultural Program in June of 2020. During the reporting period, the educator made 87 direct educational and professional contacts plus other

unknown contacts through relevant social media postings.

#### **Educational Programming, Networking and Outreach in the Local Community**

#### Farm Visits

Early on in the pandemic UW-Madison put a hold on in person visits. This moratorium made my job as an Agriculture educator a little more difficult as a large part of my job is getting out onto farms to consult with farmers and landowners directly. In order to still be effective in the community I have done what everything that I can to make sure that the citizens of Green Lake County know that even if I'm not onsite at the county building or able to come to them directly I am still available to answer calls, emails, and video chat if available. In July I learned how to navigate the approval process and I now plan to start working down the list of farms that have a standing request for a visit by the Agriculture Educator. In August there was some more clarification on how to handle these on farm visit requests. I have been able to get approval directly from my AED to visit a farm if it is related directly to growing a crop. Everything else still has to be approved by UW Madison.

#### General County Outreach

I have made sure that the citizens of Green Lake County know that even if I'm not onsite at the county building or able to come to them directly I am still available to answer calls, emails, and video chat if available. I have done that through keeping in touch with the local syndicate via a Focus Article. I have also become more active in posting

materials and resources that the citizens of Green Lake County will find helpful on our Green Lake County UW-Extension Facebook Page. My post pertaining to where local foods could be sources had a reach of over 1245 views! In August I answered calls and emails in regard to FSA programs, grazing, soil testing, soil regeneration, soil fertility, weed pressure, ornamental pruning, plant diseases, insect id, wild flower id, and chapter 12.

#### Grain Bin Meeting

On August 11<sup>th</sup> I along with Joe Zimbric of Fond du Lac County put together a webinar designed to educate participants on post-harvest handling and storage of grain. The program was requested by stakeholders Green Lake and surrounding counties. Topics covered were construction and maintenance, efficiencies in handling, and safety. The webinar was recoded and will be up for public viewing once it has been edited and closed captioned. This



webinar was offered as a replacement to the in-person workshop that was to be held in the county back in April.

#### **Networking within UW Extension and Professional Development Opportunities**

#### Agriculture Institute ZOOM Meetings

I attend the ZOOM meetings put on by the Agriculture Institute of the UW-Madison Division of Extension to keep up with the ever-changing agricultural landscape due to COVID-19. This is where I get updated on new fact sheets, new information, state and national news that may potentially affect our county stakeholders.

#### UW-Madison Division of Extension ZOOM Meetings

Once a week I tune in to the weekly update brought to all of Extension by Dean Karl Martin. Dean Martin keeps us up to date on the decisions being made in Madison and how it will look on a practical county level once implemented. The latest decision being the furlough for Academic Staff and Faculty.

#### Programming Area ZOOM Meetings

I've been meeting via ZOOM with colleagues in Farm Management and Crops/Soils to develop more web content to make our information easier to use and find. We have also been planning and developing programming for the upcoming academic year. I participated in my first webinar on video production early on in the month of July I intend to continue participating in any learning opportunities offered by the UW as it pertains to use of Webinars and Video Production.

Morgan Martinez Green Lake County 4-H Program Coordinator August 2020

This report briefly describes the work that was completed within the 4-H Program in August 2020. During the reporting period, the program coordinator made 87 direct educational and professional contacts.

#### **Program Highlights**

#### Green Lake County 4-H Leaders' Association

I supported the Association in holding their meeting via Zoom on August 6, 2020. During this meeting county-wide groups provided programming updates for their project areas, the Association discussed 4-H Charter Renewal documents, 2020-2021 scholarship application timeline, 4-H graduation recognition, and National 4-H Week Promotion.

#### 4-H Charter Help Night

On August 6, 2020 I hosted a 4-H Charter Help Night for club leaders and group executive board members to join me in learning about updates to the 4-H Charter Renewal process, answer specific questions they may have, and to assist them in completing this packet. The 4-H Charter is a legal document that indicates a 4-H Club or Group is organized in accordance with the policies and objectives of the Wisconsin 4-H program. It authorizes the club or group to use the 4-H Name and Emblem for educational purposes in accordance with laws and regulations established by Congress and the U.S. Department of Agriculture.

#### 4-H Volunteer in Preparation Training

On August 7, 2020 I hosted Volunteer in Preparation Training via Zoom for one new 4-H volunteers! The primary purpose of Volunteer in Preparation Training is to ensure the safety and well-being of all participants. The Wisconsin 4-H Youth Development Youth

Protection program process includes:

- Completion of the Volunteer Application Form
- Online Mandatory Reporter Training for Volunteers
- Participation in a volunteer orientation session
- Background records check for arrest and conviction records

Green Lake County welcomed Jennifer Decker as a new Green Lake County 4-H Volunteer.



#### United Migrant Opportunity Services (UMOS) Lesson



On August 4, 2020 and August 12 I taught STEM lessons to young people at UMOS Childcare Center via Zoom. In the first lesson participants got to use their engineering skills to make and build a kite of their own. Participants tested out their kite designs and learned how lift and air pressure work together to make things fly! In the second lesson participants explored simple machines, force, and motion to create a cotton ball catapult.

#### 4-H Record Book Q&A Sessions



4-H members annually are encouraged to complete a 4-H Record Book to reflect on the past 4-H year and all that has been learned and to look ahead to the new 4-H year on what they would like to further explore! - Virtual and distance programs continue to be preferred method.
- Volunteers can work with county 4-H educator to complete a program planning guide to request to hold in-person programs with groups of 10 or fewer.
- More than one group (each under 10 individuals) may meet in outdoor or multi-room locations
  where the groups can remain separated and physically distant where total numbers do not
  exceed 50 individuals.
  - Groups may use separate spaces in the same venue such as a school, library or community center where groups remain in different rooms and physically distant throughout the event.
  - Groups may use several areas within a park or other large outdoor space.
- All in-person programs must following a safety checklist. Some criteria include:
  - Indoor gatherings are limited to 2 hours.
  - o 6 feet minimum distancing between participants is required at all times.
  - Physical distancing is not required between members of the same household, however each member is counted in the maximum group size.
  - Hand sanitizing equipment (soap and water is preferred, or hand sanitizer with at least 60% alcohol, tissues, and no-touch trash cans) must be readily available and frequently used.
  - Face masks or coverings are required even when speaking.
