Community Health Action Team (CHAT) - Munsey reported Early Childhood parenting program has started. 5 Families have signed up for this so far. Discussion followed.

Opioid Fatality Review: Munsey reported this is a Tri-County Grant. Green Lake County had the first review that was conducted in September 2020. The second review happened in Marquette County in December 2020. A number of recommendations have been made. An additional grant was written to continue this process for another year. Discussion Followed

<u>COVID Update</u>: Munsey reported 1,427 positive cases, 375 probable cases, 6,874 negative, 14 deaths and 3 additional probable deaths. Munsey

reported 150 Pfizer vaccines are coming to Green Lake County Public Health office today (1/13/21). 7 day average for Green Lake County has been less than 10 cases per day. Discussion followed.

<u>Budget Discussion:</u> Munsey reported 2021 budget passed and has been implemented. Munsey stated there will be COVID Funding for 2021. Discussion followed.

Staffing Update: Munsey stated that Kayla Yonke, the Health and Human Services Financial/Business Manager, will be taking minutes for the Health Advisory meetings due to Karen Davis, previous secretary, retiring.
