FINANCE COMMITTEE January 27, 2021

The meeting of the Finance Committee was called to order by Chair Harley Reabe on Wednesday, January 27, 2021 at 4:00 PM, in the County Board Room and via Zoom format at the Government Center, Green Lake, WI. The requirements of the open meeting law were certified as being met. The Pledge of Allegiance was recited.

MINUTES

Motion/second (Abendroth/Lenz) to approve the minutes of the December 22, 2020 meeting with no additions or corrections. Motion carried with no negative vote.

TREASURER'S MONTHLY REPORT

• Tax Collection Update

Treasurer Amanda Toney stated that \$14 million in taxes has been collected as of January 26, 2021. Mail payments have increased this year due to the pandemic but many people still choose to come in and pay in person.

• December Financial Reports

Treasurer Amanda Toney asked if there were any questions on her submitted written report. Discussion held on declining interest rates.

• Sales Tax Update

Treasurer Amanda Toney stated that 2020 ended with an 11.86% increase in sales tax over 2019. Several months were at a record high.

IN REM UPDATE

Treasurer Amanda Toney reported no changes from last month.

BUDGET ADJUSTMENT

• CARES Funding

Budget adjustment as presented by County Administrator in the amount of \$8,413.50

• Sheriff's Office

Budget adjustment for 2021 in the amount of \$6,999.00 for drone to have a dual camera system. Sheriff Mark Podoll explained the request to the committee.

• Land Use Planning & Zoning

Budget adjustment for 2020 to cover outside legal counsel expenses due to conflict of interest in the amount of \$2,958.00.

The January sales tax deposit was \$129,049.30. This is a 0.25% increase over the January 2020 amount.

TAX COLLECTION UPDATE:

As of today, we have collected and settled for \$29,929,254.84 in Real Estate and Personal Property taxes, out of \$42,929,923.12

Jess, Stef and I have completed the February Settlement process. Stef has also completed creating the assessment rolls for the 2021 tax cycle.

On March 1, 2021, the County will make a loan payment to the Depository Trust Company for \$860,613.75.

Justice Center Principle – \$715,000.00

Justice Center Interest – \$145,613.75

In March, we will begin the In-Rem process for those parcels with delinquent 2017 taxes.

Per the January credit card statement, we have a balance of 1,949,251 credit card points. The county has earned an additional 23,114 points this statement. This calculates to \$19,492.51.

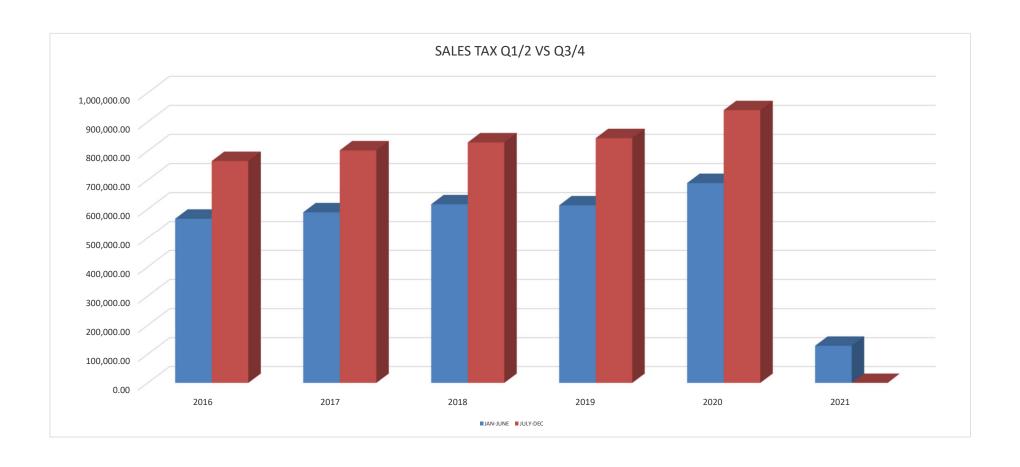
