#### **MINUTES**

#### REVIEW OF CURRENT BYLAWS

Discussion held on the current bylaws and changes that need to be made. Liz Otto will work with Corporation Counsel Dawn Klockow to draft a resolution for discussion and approval at the next meeting.

#### REVIEW AND DISCUSSION OF 2016 COMPREHENSIVE PLAN

Chair Kemnitz stated she submitted this to the committee for information purposes. Many of the statistics are from 2000 so have changed since that time. Discussion held.

### **REVIEW AND DISCUSSION STRATEGIC PLAN**

Discussion held on the short and long term vision plan for the EDC. Keri Solis, Marquette County Economic Development Coordinator, gave an overview of her position and some examples of projects she has implemented. Chair Kemnitz asked each of the members to bring forward their ideas at the next meeting for a vision statement.
