## • DNR Grant for Lauree's Trail – Phase II

County Clerk Liz Otto informed the committee that a grant in the amount of \$195,000.00 for Phase II of Lauree's Trail has been awarded from the DNR. Corporation Counsel has approved the contract so the paperwork will be signed and returned to the DNR.

## **DISCUSSION AND OPTIONS REGARDING TRASH AT COUNTY PARKS AND RESTROOMS**

Maintenance Supervisor Scott Weir outlined his recommendations for reducing the trash problem at county parks and restrooms including signs on the dumpsters, putting trash containers at Sunset Park by the bathrooms, putting trash containers at Dodge Memorial Park by the launch bathrooms and the pavilion, and possible timer locks on the bathrooms. The committee recommended signs and cameras for both Dodge Memorial and Sunset Park.

## HIGHWAY TRAFFIC SAFETY RECOMMENDATION FOR SUNSET PARK

Chief Deputy Matt Vandekolk recommended the committee approve the north side only entrance and south side only exit. The sidewalk will not be implemented due to cost. 2 way traffic will be allowed inside of the park between the parking lots. The committee approved of these implementations through general consensus.

## **DEPTH OF BOAT LAUNCHES AT DODGE MEMORIAL COUNTY PARK**

Charlie Wielgosh stated he has received numerous questions/complaints about the depth of the boat launches at Dodge Memorial Park. Only one launch is useable for larger boats due to the shallowness of the water. Discussion held on options and the cost involved.
