# Land Conservation Committee July 8, 2021 Monthly Staff Report

# **June Projects**

- 1. Monitor current erosion control permits for compliance with county ordinances and review new permit applications for erosion control and storm-water management.
- 2. Conduct Farmland Preservation Program spot checks throughout county.
- 3. Conduct the County Transect Survey.
- 4. Meet with landowners to discuss possibility of BMP's on their properties.
- 5. Layout potential projects for a few landowners so they can visualize the footprint.
- 6. Assist Jerry Stanuch (GIS) in locating and surveying manhole covers using our survey equipment so he can create a map for the Sanitary District.
- 7. Assist Green Lake Association in planting 20 trees in the Dakin Creek stream restoration corridor.

#### **July Project Focus**

- 1. Continue Farmland Preservation Program spot checks throughout the county as weather and landowners permit.
- 2. Continue to monitor existing erosion control permits, and review and issue new erosion control and storm-water management permits for applicants.
- 3. Complete the Green Lake County Transect Survey for remaining lands that were idle during first survey (late planted fields).
- 4. Begin construction of a grade stabilization structure, rock-lined waterway, and two grassed waterways in the Town of Green Lake once wheat is harvested.
- 5. Begin construction for an underground outlet in the Town of Green Lake once wheat is harvested.
- 6. Begin construction of a grade stabilization structure, rock-lined waterway, grassed waterway, and outlet protection once bids received and as soon as awarded contractor can begin.

### Lake and River Report

<u>Puckaway</u> – Received several calls concerning low water levels and plant growth on the lake. Water levels are caused by lack of rain and pland growth is a combination of two years of high water, and high temperatures early in the season. Brought aquatic plant chemical applicator out on the plan at the request of the Lake District to observe the plant growth and develop a navigation plan (chemically treated pathways) to reach deeper water from impacted docks. Surveying water levels and dam elevations on regular basis to recalibrate hydrographs for the Fox River following the update of the lock and dam system. Met with owners for shoreland restoration planning. Attended annual District meeting to present on the dredgebank restoration and address questions/concerns. Attended planning meeting for Dredgebank.

<u>Twin Lakes</u> – Permits for Cattail Control have been issued. Treatment planned for June. Met landowner to remedy sidehill seepage problems on the lakeshore. Working with contractors and DNR to reestablish access to Little Twin Lake which has been blocked for 18 months due to floating bogs blocking the navigation channel.

**Spring Lake** – No updates.

<u>Little Green</u> – No updates.

<u>Green Lake</u> — Attended meeting with consultants to discuss nutrient trading credits from BMP installation. Toured stream restoration site. Met with several landowners for shoreland restoration planning.

<u>Grand Lake</u> – Waiting for Dye study results from consultant.
