Call to Order: The meeting called to order at 9:00 a.m. by Beuthin.

85.21 Specialized Transportation Association Grant Update: Bradley stated the 85.21 grant application for 2022 was completed. Bradley reported that the money and distribution is very similar to previous years. Bradley stated in 2022 85.21 trust fund money will be used as a match for a Southern Green Lake vehicle. Bradley also stated the City of Berlin will be writing their own 5310 grant to get their own vehicles in the future. Grant Application was reviewed and placed on file. (Bender/Buss) motion/second to forward Grant application to Health and Human Services Committee for approval. All Ayes, Motion Carried. Discussion followed.

5310 Grant Update: Schuh stated the 2022 5310 grant was written for 3 vehicles in 2022. 1 minivan for Southern Green Lake County, 2 mini buses for Fox River Industries. Fox River Industries also wrote for operating grant dollars for 2022. Schuh stated we have not yet heard what/how much of the grant funding we will be awarded. Discussion followed.

<u>Gas/Repair Costs:</u> Schuh reported cost through the local gas stations and Green Lake County Highway Department. Green Lake County rate are - Gas - \$1.94 and Diesel - \$1.99.

<u>Veterans Transportation Update</u>: Vandeyacht stated the transportation numbers have doubled from last year but still not consistent with what they had been prior to COVID. Vandeyacht stated Department of Wisconsin Veterans Affairs Grant was submitted in October but not anticipating it

will be as much as previous years. Vandeyacht stated we currently have 2 drivers and they are able to cover the rides requested. Discussion Followed.
