RESOLUTION NUMBER -2021

Resolution Designating the Office of Corporation Counsel to Represent the Interest of the Public for Legal Actions under the Children’s Code pursuant to Wis. Stat. §48.09(5)

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting on this 21st day of December 2021, does resolve as follows:

- 1 **WHEREAS**, when a child is assessed to be unsafe in their home due to abuse or
- 2 neglect, the County Children & Family Services unit of the Health and Human Services
- 3 Department may request the District Attorney file a Child in Need of Protection or
- 4 Services (CHIPS) petition in circuit court pursuant to Wis. Stat. §48.13; and
- 5 Majority vote is needed to pass.
- 6 Judicial Law/Emergency Management Committee approves disapproves

7 **WHEREAS**, the Adoption and Safe Families Act requires that a Petition for the
8 Termination of Parental Rights (TPR) be filed if a child remains in an out of home
9 placement due to the parent's inability to meet conditions for the child's return to their
10 parental home for at least 15 out of 22 months in order for the child to have permanency
11 through adoption; and

12 **WHEREAS**, The Green Lake County Office of the District Attorney represents the
13 Interests of the Public in CHIPS actions under Wis. Stat. §§48.13, 48.133 and 48.977
14 and the Green Lake County Corporation Counsel prosecutes the TPR petitions under
15 Wis. Stat. §48.417. This split of statutory duty results in difficulty for the prosecution for
16 TPR petitions because the Corporation Counsel must learn the case from the
17 beginning; and

18 **WHEREAS**, Wis. Stat. §48.905(5) states that the Interests of the Public shall be
19 represented by the District Attorney, or if designated by the County Board of
20 Supervisors, by the Corporation Counsel. The Board may do so, but must inform the
21 Department of Administration before January 1 of the year the duties are transferred;
22 and

23 **WHEREAS**, the actual costs incurred by Corporation Counsel in prosecuting CHIPS
24 and TPR court proceedings can be offset by making a claim for IV-E legal funds through
25 the Wisconsin Department of Children and Families. Approved claims are reimbursed
26 at the rate of 28% for CHIPS actions and 39% for TPR actions. Claims may be made
27 for personnel costs including attorney and clerical support, genetic testing fees, service
28 of process fees, publication and transcription costs, and others. The Office of
29 Corporation Counsel has entered into a IV-E agreement each year to recoup the costs
30 of the TPR actions and can do the same for CHIPS actions.

31 **WHEREAS**, CHIPS and TPR prosecution are mandated services that the County must
32 provide to ensure the safety and well-being of all our children; legal services provided
33 by the Office of Corporation Counsel will result in streamlined case activity between
34 DHHS-children and families unit and the Corporation Counsel; and effective and
35 efficient case prosecution will result in a child's safe return home or a permanent home
36 through guardianship or adoption; and

37 **WHEREAS**, The HHS Director, Children & Family Unit Manager, District Attorney and
38 Corporation Counsel have met and discussed the transfer of duties and are in
39 agreement; and

40 **WHEREAS**, the caseload is one that the Office of Corporation Counsel can easily
41 absorb.

42 **NOW THEREFORE BE IT RESOLVED**, that the Green Lake County Board of
43 Supervisors designates the Office of Corporation Counsel to represent the Interests of
44 the Public for Actions under Chapter 48, Children's Code, pursuant to Wis. Stat. §48.09
45 effective January 1, 2022.

46 **BE IT FURTHER RESOLVED**, that the Count Clerk shall deliver a certified copy of this
47 resolution to the Wisconsin Department of Administration no later than December 31,
48 2021.

49 **FISCAL NOTE:** unknown revenue potential. As of November 18, 2021, Corporation
50 Counsel has received \$2,074.41 in TPR State Grant revenue for three open cases.
