More Veterans are feeling comfortable enough to get out and ask for assistance. He reports there have been 19 claims submitted between 1 Jan to 1 April and another 10 or 11 in various stages of work.

Vandeyacht reported he expects are larger number of claims requests this year as word about the new presumptives for Agent Orange are now getting processed. He expects that the proposed 'Honoring our Pact Act' will get passed adding another presumptive to Agent Orange as well as a bunch of cancers along with a few other health effects to the presumptive list for those deployed to the middle east.

Financial Report: After discussion, Burdick made a motion to approve the Financial Report as submitted. Second by Shrock All ayes. Motion carried.
