Call to Order: Prellwitz called the meeting to order at 8:02 a.m.

Approval of Minutes: Motion/Second (Brandstetter, Bending) to approve the minutes from October 13, 2021 Health Advisory Committee meeting with to grammar corrections, All Ayes Motion Carries.

Environmental Health Update: Prellwitz reported Kyle Alt is the new Environmental Health Specialist started on November 15, 2021. Prellwitz reported on October – December Reports. Discussion Followed.

Quarterly Report on Health Unit Activities:

Prellwitz reported the Wisconsin National Guard helped with vaccine clinics from October 20, 2021 through December 15, 2021. Currently Green Lake County is using AMI to help with vaccine clinics.

Prellwitz reported Carbon Monoxide campaign has kicked off. Green Lake Public Health is working with local fire department and other community partners to distribute Carbon Monoxide detectors to local community members and providing education on preventing carbon monoxide poisoning.

Prellwitz reported on Tobacco prevention. Green Lake County is a part of the 5 Counties for Tobacco Free Living group. In the past, Fond du Lac County was doing the compliance checks in Green Lake County, Green Lake County has recently taken over our own county's tobacco compliance checks, which will resume in July.

Opioid Fatality Review: Prellwitz reported a case review was done on December 16, 2021. One of the items that came out of the review was a discussion on Narcan distribution after release of incarceration. Prellwitz reported that some jails are on board with this and some are not. Discussion Followed.

Previously in Green Lake County we had a child death review team, this team will be a Tri-County effort with Green Lake, Waushara and Marquette counties. The purpose of this team will be the same as the Opioid Fatality to, better understand and prevent future deaths. Discussion Followed.

COVID Update: Prellwitz COVID update was reviewed and placed on file.

Prellwitz reported yesterday Green Lake County had over 50 positive cases. Priorities for Contact tracing are school aged children, high risk setting cases, and front line workers. Regardless of your occupation or age everyone receives a letter or email if they do not receive a phone call.

Green Lake County is in critically high category for case activity and also high community transmission.

Prellwitz reported vaccine rate have not gone up much recently, but Green Lake is trying to encourage staff and community members to get vaccinated.

Prellwitz reported there is new isolation and quarantine guidelines. The guidelines were reviewed. Green Lake County is going to the shortened guidelines which is not applicable for schools, daycares, and hospital settings. Discussion Followed.

Annual Report: Motion/Second (Brandstetter/Thumer) to forward the 2021 Public Health Annual report to Health and Human Service Committee and County Board for full approval. All Ayes. Motion Carried.

Prellwitz reported some of the highlights for 2021 was Kathy Munsey's retirement, focusing on vaccination clinics for 2021, and all of the other programs took a back seat. 2021 Annual Report was reviewed and placed on file. Discussion Followed.

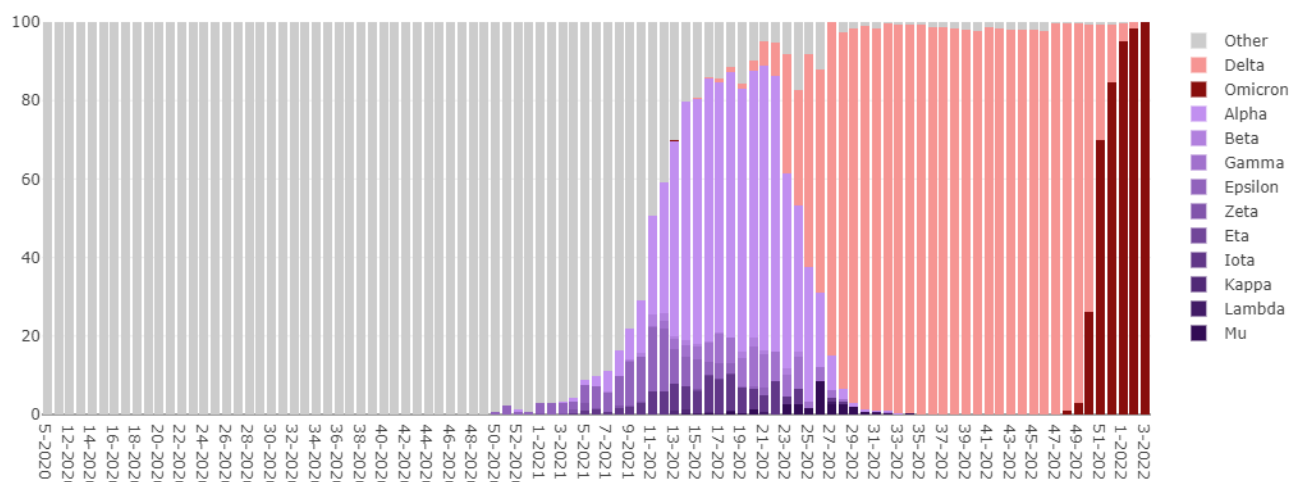

### January 2022 Health Unit Monthly Report to the Health & Human Services Board

#### COVID-19 Cases Update:

- Green Lake County is currently (as of February 2, 2022) listed in the CRITICALLY HIGH category for case activity and HIGH for community transmission. We have seen a surge in case activity and breakthrough cases throughout January, averaging 30 to 40 new cases per day (up from 16 to 18 last month).
  - Total case count= 4,832 (Up **883 cases** since last month)
- The Omicron Variant is being detected in 100% of specimens being sent for sequencing. Chart from WSLH Variant Report: [WI SARS-CoV-2 Genomic Report \(wisc.edu\)](#)



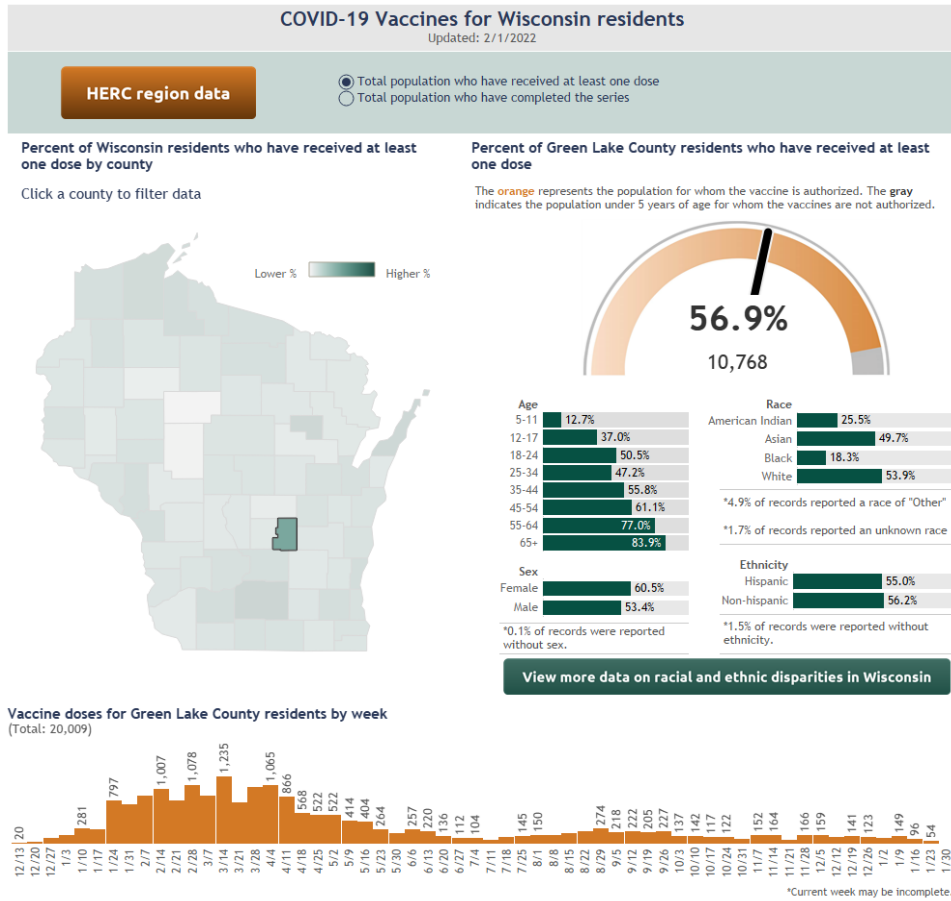
#### Public Health Update:

- “Walk-in Wednesdays” will continue with J&J, Moderna, & Pfizer vaccine available. Supported by AMI through March.
- We will begin offering COVID-19 vaccine appointments every day beginning next week. Appointments must be made with HD staff (primarily Allison).
- DHS updated guidance for disease investigations/contact tracing. Focus to shift to prevention strategies instead of individual case follow-up.
- N95 masks ordered through DHS stockpile for public mask requests.



**Vaccine Updates for Green Lake County Residents:**

- 56.9% of GLC residents have received at least one dose of COVID-19 vaccine.
- 53.6% have completed the vaccine series.



**Other Updates:**

- Our focus for the month of January continued to be on COVID-19 response.
- We have joined with Waushara and Marquette counties to form a Tri-County Death Review Team. GLC previously had a Child Death Review Team which has not meet after Coronor Thoma left. The purpose of Death Review Team is to better understand the risk factors and circumstances surrounding a person's death and to develop policy and program recommendations to prevent future deaths. This committee meets quarterly with cases being presented from one of the three counties on a rotating basis.

## Behavioral Health Unit—January 2022

**COVID19 Update:** There have not been substantial changes to our clinic operations due to Covid-19 this month. Behavioral Health Unit did experience approximately one week where over 50% of the staff were in quarantine situations, however due to the availability of telehealth platforms and remote work, most services were able to continue with minimal disruption during this time. Last month, Forward Health released guidance on their permanent telehealth policy which does allow for the continuation of telehealth services. Currently, Forward Health continues to operate under the pandemic-related emergency policy, however this permanent policy will go into effect the first day of the month after the pandemic-specific policy ends.

**Outpatient Mental Health (MH) & Substance Abuse (SUD) Programs-** *The majority of Behavioral Health clients are served via our outpatient clinic. The outpatient clinic serves clients' mental health and substance use disorder (SUD) needs.*

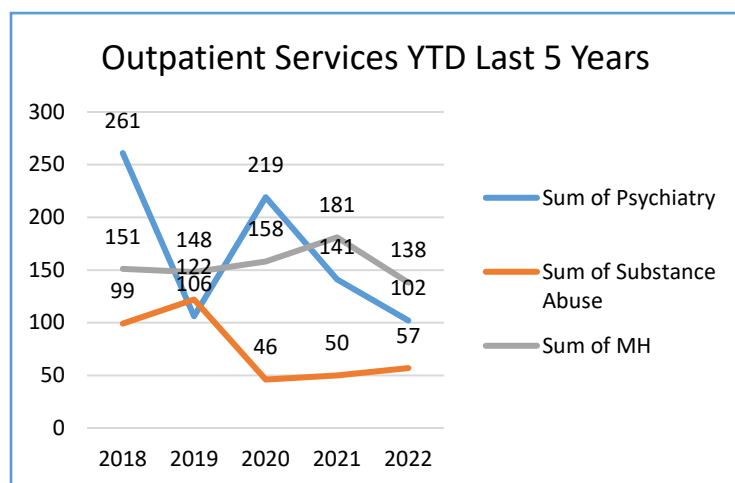


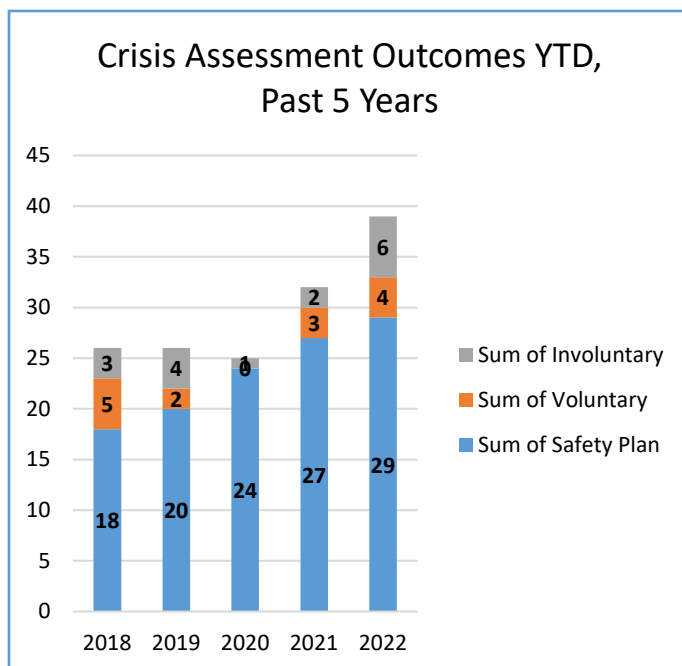
Figure 1: Psychiatric services data have varied. This is because of changes both the schedule of the staff psychiatrist and the frequency of pre-prescriber nurse visits and fluctuations with COVID-19 impact in-person services. **Mental health services are lower than average this month due to a full-time clinician being absent on a temporary medical leave.**

### January Note:

1. Clinicians continue to have full caseloads, however we are optimistic that the addition of a new therapist position will assist with this and expand our capacity in the outpatient clinic.
2. Regarding substance use services, clinicians continue to work to resume group treatment options with an additional therapy group set to resume in February in a virtual format.
3. Brooke Zank, LPC (who is currently employed with Behavioral Health as our CSP Case Manager) was offered the newly created, additional therapist position. Brooke continues to transition into her new role while also assisting with training the new CSP Case Manager.
4. Sara Rhode was offered and accepted the newly created lead therapist position.
5. A revised version of DHS 75 has been released. DHS 75 is the administrative code that governs SUD programming. The new version will cover “integrated behavioral health services” (encompassing both our MH and SUD programs under one certification) and goes into effect 10/2022. More information will be shared as it is available.

**Wrap-Around Services-** *Behavioral Health Unit provides three tiers of wrap-around services, allowing us to match individuals with a program that meets the level of need based on their unique situation.*

1. **Targeted Case Management (TCM)**— *Less intensive case management for clients. **This program expanded to include adult clients in summer 2018. It presently serves 11 individuals.***
2. **Comprehensive Community Services (CCS)**—*Recovery-focused support for clients who may benefit from an intensive level of services for a shorter period of time. **This program serves individuals across the lifespan and presently serves 41 individuals.***
3. **Community Support Program (CSP)**- *Intensive community-based support for individuals with chronic mental illness. This support is intended to be long-term and supports clients to maintain psychiatric stability in the community and to reduce hospitalizations. **This program presently serves 17 adults.***



**Crisis Services-** *Crisis services are available 24/7 including weekends/ holidays for psychiatric and substance use disorder emergencies*

In January 2022, we continued to see increase in crisis responses consistent with last year. Currently, emergency detentions represent 15%. At this point in prior years, emergency detentions accounted for closer to 13% of the contacts. Year-to-date calls represent a 21.9% increase from this same time last year. The data represent new crisis calls each month. The crisis team provides additional follow up services to clients after their initial contact. This differs case-by-case basis, however crisis follow up can last anywhere from 30 days to 6 months. **Previously, I have reported on implementation of the 988 national calling code for MH emergencies. There are no additional updates on this area. I will continue to report information as available.**

**Substance Use Services Case Management-** *The substance use-specific case manager works within a variety of the programs provided above. This position may provide crisis case management, outpatient services, Targeted Case Management (TCM) or Comprehensive Community Services (CCS) as determined based on the needs of the client. This individual will also assist with requests for residential treatment funding from outside providers. This position was newly created, starting in January 2022 and has served 5 clients so far for case management, 2 outreach/early intervention clients, and an additional 3 clients for outpatient services. As the position continues to develop, we anticipate that this position will serve a full caseload within the next 2-3 months. Additionally, during January 2022, Wisconsin DHS announced funding available through the McKinsey Settlement for the purpose of supporting room and board costs for residential treatment centers. Presently, this level of treatment is covered by Medicaid but the room and board costs are not. These costs are prohibitive for many individuals seeking residential care. This funding, if awarded, would specifically offer support for individuals with opiate-related diagnoses seeking residential treatment through the year of 2022 only.*

**Children's Long Term Support Waiver (CLTS)**—*Medicaid waiver program provides funding for families of children with long-term disabilities (developmental, physical, and/or severe emotional disturbance) to access services such as respite care and service coordination which are otherwise not covered by Medicaid insurance. In 2018, Wisconsin announced the dissolution of the local waitlist and then subsequently the transition to a state-wide waiting list model. This month, the state announced the dissolution of the state-wide waiting list as well. Starting at this time, youth who are screened eligible for CLTS services will automatically be placed into "enrollable" status with the expectation that the waiver agency will then open them within the allotted time period (we are awaiting further guidance on this but anticipate the time period to be 30 days). Our current program census is at 45 youth.*

Treatment Foster Care – **Two (2)** children/youth were in treatment foster care through Pillar & Vine during the month from Green Lake County.

Court-ordered Relative Care (\$300.00 month per child)

Total in Court-ordered Kinship Care during the month = Nine (9). One (1) new child entered relative care. One (1) Child was subject to TPR and one (1) child was reunified with a parent. Three (3) of the relative placements are non-paid. Total in Court-ordered relative placement at month's end = **Eight (8)**

Subsidized Guardianship – At the end of January 2022, **three (3)** remained in subsidized guardianship. One (1) guardian has petitioned the court to rescind the guardianship which will cause the child to return to foster care.

Kinship Care – Voluntary (\$300.00 month per child)

**Eight (8)** children were in Kinship Care at the end of January 2022.

Total out of home at month's end = 4 + 2 + 8 + 3 + 8 = **25**

The base rate for relative foster care (level 1) and Kinship Care rates increased in 2022 to \$300.00/month.

Foster Home Licensing – **Two (2)** relative homes were denied licensure. **Two (2)** relative homes are in the process of being licensed.

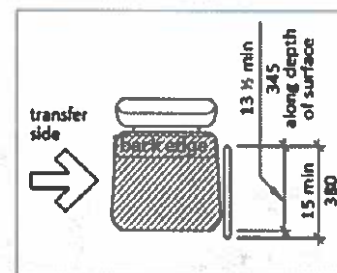
## The Americans with Disabilities Act of 1990

The Americans with Disabilities Act of 1990 (ADA) and Section 504 of the Rehabilitation Act of 1973 are federal civil rights laws that prohibit discrimination against individuals with disabilities in every-day activities. In 2010, Section 510 was added to the Rehabilitation Act of 1973 that requires the Access Board to issue standards for medical, dental and ophthalmic diagnostic equipment to ensure such equipment is accessible to, and usable by, individuals with disabilities.<sup>4</sup>

In 2017, the U.S. Access Board added part 1195 to title 36 of the Code of Federal Regulations as a published document in the Federal Register to meet the requirements of Section 510 of the Rehabilitation Act of 1973 for an ADA Compliant chair and table<sup>4</sup>. Two of the key components to this regulation are the entry height of 17"-19" and a patient transfer support, with which MTI's ADA Compliant chairs and tables comply.
