#### Discuss Highway Property Improvements Related to the County Jr. Free Fair

Committee members were updated on the Ag/Extension Committee requesting \$34,850 from the General Fund Reserve at the June Finance Meeting to be transferred into the Highway Fund for improvements at the fairgrounds. County Administrator, Schmit advised not to transfer money from the General Fund, but to include in the Highway Budget through the tax levy. It was also noted that Highway has not yet seen an itemized list of requested improvements through discussions from last year.
