The first quarter of EMS Services has ended. We have processed all our bills and revenues for that time. I have attached an invoice outlining our base services rendered, a breakdown of all revenues received during that time, as well as an expenditure report from our accounting software program. If you would like any further information concerning any of the charges, please let me know.

The total amount of expenditure for EMS Services from January 1st to March 31st was \$266,381.33. According to our Billing Provider Cvikota, during that time, we received \$42,909.67 in revenue for EMS services from January 1st to March 31st. The balance due to Green Lake County for Base Services rendered in the first quarter is \$223,471.66.

We have no Disaster Services or EMS Emergencies to request reimbursement for in this quarter.

One note - this quarter had a lot of overtime being utilized as we continued with the hiring process for the Princeton location. At this time, we have staffed the Princeton location and it is operating, therefore, less overtime will be utilized to fill in open shifts. That should be reflected in future quarterly invoices.
