Our hands are tied until the response and release from this office is received by us. We are "at the mercy" of how timely and efficient this office operates. Which lends to my concern of coverage of the complete county, while addressing the cases of additional county.

We have been blessed with a wonderful register of deeds office, who dispatches our required documents in more than a timely manner. But that hinges on the timely response from the ME's office with the necessary response time with their portion of our documents.

Families have a difficult time understanding why these things take so long, when they need to get their personal, financial, legal, and property issues addressed while they are together.

This position is so very important, maybe, a pause to expand the possibilities of obtaining teaming with adjoining counties should be studied and compared.

# Resolution relating to PSAP Grant Funding for One Public Safety Answering Point per County

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting on this 16th day of August 2022, does resolve as follows:

- 1 WHEREAS, every municipal and state agency that provides fire suppression, law
- 2 enforcement, and EMS, may establish a 911 system. Most counties operate their own
- 3 Public Safety Answering Point (PSAP) to meet the needs of their citizens; and
- 4 WHEREAS, the 2017-19 Wisconsin state budget required DMA to create an emergency
- 5 services IP network to be provided to all PSAPs. This digital network is essential in
- 6 transitioning the state's 911 system from the old and outdated analog system to a
- 7 current and advanced NextGeneration 911 system; and
- 8 Fiscal note is not applicable.
- 9 Majority vote is needed to pass.
