**June 15, 2022**

The meeting of the Multi Use Path Governing Board was called to order by Chair Barry Rogers on Wednesday, June 15, 2022 at 1:00 PM, in the County Board Room and via Zoom format at the Government Center, Green Lake, WI. The requirements of the open meeting law were certified as being met. The Pledge of Allegiance was recited.

**APPROVAL OF 05/18/2022 MINUTES**

***Motion/second (Sharp/Mashuda)*** to approve minutes from the 05/18/2022 minutes. Motion carried with no negative vote.

**PUBLIC COMMENT (3 MIN LIMIT)** - none

**UPDATE ON CONSTRUCTION**

Chair Rogers stated that work continues on Phase II of the trail. Construction is currently running about a month behind schedule due to bad weather but completion is expected by July 10, 2022. Rogers explained the easement process and the compliance requested by the DOT.

**DISCUSSION REGARDING PHASE III OPTIONS**

Chair Rogers presented a map outlining the proposed options for Phase III of the trail which will allow users access to downtown Green Lake from Fortifi Bank on the corner of Hwy 23 and Hwy 49. Rogers outlined the DOT suggestions and asked for feedback from the committee. Highway Commissioner Derek Mashuda suggested moving the crossing point to Hwy 49 but move it further north for safety reasons and less confusion for users and motorists. Discussion held. Mashuda will provide traffic volumes for CTH A, Hwy 49, and Hwy 23.
