UPDATE ON COMPLETION OF PHASE II

Barry Rogers stated that blacktopping has been completed from Sunnyside to Forest Ridge Road. Landscaping, seeding, and signage will be completed soon.

DISCUSSION REGARDING PHASE III PLANS

Barry Rogers stated that the DOT has contacted Green Lake Greenways in regard to crossing Highway 23. Preliminary work was done by MSA for the use of CTH A to Commercial Avenue. The safer option would be cross STH 49 to get into Green Lake off of North Lawson but funding is available for 2023 for Highway 23. Greenways has been advised to apply for 2 grants – one now and another later for the other route.
