# **August 8, 2022**

The regular meeting of the Parks Commission was called to order by Chair Bill Boutwell on Monday, August 8, 2022 at 3:00 PM in the Green Lake County Board Room, Green Lake County Government Center, 571 County Road A, Green Lake, WI. The meeting was held both in person and via Zoom. Requirements of the open meeting law were certified as being met. The pledge of allegiance was recited.

*Motion/second (Roberts/Morris)* to approve the minutes of the July 11, 2022 meeting. Motion carried with no negative vote.

# CORRESPONDENCE REGARDING MEMORIAL BENCH AND SUNSET PARK

Parks Director Scott Weir stated he received correspondence from Karen Boegel requesting permission to donate a bench at Sunset Park. In the past the donor pays for the materials and the Maintenance Department donates their time to install it. *Motion/second (Morris/Roberts)* to approve the donation. Motion carried with no negative vote.

#### **APPEARANCES**

- Wisconsin Lake and Pond Resource LLC Jim Scharl, Lakes Services Manager, provided information to the committee regarding the options for duckweed removal:
  - 1) Chemical removal Scharl stated that the DNR will not allow this option through a required permit
  - 2) DASH (Diver Assisted Suction Harvesting) this only works on the duckweed at the time of harvest it doesn't take care of any future problem so it must be repeated as needed. Large equipment is required.
  - 3) Manual removal this is accomplished by watermovers installed on the docks for approximately \$1500 each. There are several in use on Green Lake at this time.
- Hannah Butkiewicz, Golden Sands RC&D Invasive Species Grant

  Ms. Butkiewicz provided information regarding the US Forest Service Great Lakes Initiative Grant for up to \$50,000 to support outreach and education, inventory and control work for invasive species. They are requesting a letter of support and either a cash donation or volunteer work to match 20% of the funds along with other partnering counties.

# <u>DISCUSSION AND POSSIBLE ACTION ON LETTER OF SUPPORT FOR GOLDEN SANDS RC&D INVASIVE SPECIES GRANT</u>

*Motion/second (Morris/Wielgosh)* to direct Todd Morris to write a letter of support and agree to an in kind donation through Land Conservation for work hours up to \$3,300 in the next 3 years. Motion carried with no negative vote.

#### **DISCUSSION ON BOAT LAUNCH FEES**

Chair Boutwell stated that boat launch fees should remain the same but funds should start being spent for improvements. *Motion/second (Specht/Roberts)* to approve installing 3 watermovers at Sunset Park for duckweed mitigation to be paid for with boat launch fees. Motion carried with no negative vote. Chair Boutwell directed committee members to provide other improvement ideas at the next meeting.

#### **2023 PARKS BUDGET**

Scott Weir stated there was a typo on his submitted budget and the Boat Launch Maintenance line item should be \$23,860 instead of \$22,180.
