

Resolution to utilize American Rescue Plan Act (ARPA) funds for Green Lake County Groundwater Program

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting begun on the 21st day of MARCH, 2023, does resolve as follows:

- 1 WHEREAS, Green Lake County Health and Human Services Department applied for a
- 2 grant in 2019 to provide well testing for 150 wells in the county. This program was very
- 3 well received by the public.
- 4 **WHEREAS**, results from this initial testing identified two distinct areas in the county that
- 5 had high percentages of tested wells with elevated nitrate levels.
- 6 WHEREAS, the Green Lake County Groundwater Program will concentrate well testing
- 7 in these elevated areas, targeting households that did not participate in the 2019 study
- 8 and families with infants.
- 9 Majority vote is needed to pass.

High levels of nitrate in drinking water can affect everyone.



Nitrate may cause birth defects.

This can affect women who are or may become pregnant.



Nitrate can cause blue baby syndrome.

<u>Protect yourself and your family</u> by testing your well every year for nitrate and finding a safe source of water if levels are high.

Blue Baby Syndrome (or methemoglobinemia)



Nitrate can affect how our blood carries oxygen. Nitrate can turn hemoglobin (the protein in blood that carries oxygen) into methemoglobin. High levels can turn skin to a bluish or gray color and cause more serious health effects like weakness, excess heart rate, fatigue, and dizziness. Nitrate can affect babies more seriously because their bodies interact with nitrate differently.

When nitrate levels are high, water should not be given to babies less than 6 months old or used to make infant formula.

Birth Defects



High levels of nitrate in drinking water may cause neural tube defects (a type of birth defect). The neural tube turns into the brain and spine in an unborn baby. Neural tube defects can occur very early in pregnancy.

When nitrate levels are high, women who are or may become pregnant should immediately stop using the water for drinking and preparing foods that use a lot of water.

Thyroid Disease



High levels of nitrate in drinking water may increase the risk of thyroid disease. Nitrate can affect how the thyroid functions by blocking the uptake of iodine. The thyroid needs iodine to make hormones. Low levels of thyroid hormone levels can cause fatigue, weight gain, dry skin, hair loss, and goiters (enlarged thyroid).

When nitrate levels are high, everyone should avoid long-term use of the water for drinking and preparing foods that use a lot of water.

Cancer



High levels of nitrate in drinking water may increase the risk of colon cancer. Nitrate may enhance the cancer potential of other compounds or may turn into cancer-causing chemicals like the body. Nitrate in drinking water has not been shown to increase the risk of other kinds of cancer.

When nitrate levels are high, everyone should avoid long-term use of the water for drinking and preparing foods that use a lot of water.

We are still learning about the health effects of nitrate.

Some studies have suggested that nitrate may be associated with miscarriages, diabetes, acute respiratory tract infections in children, and macular degeneration. However, additional information is needed to determine the relationship between nitrate and these effects.



WHY SHOULD I TEST MY WELL?

Private-well owners are responsible for regularly testing and maintaining their well. Unwanted substances known as contaminants can get into private well water.

Contaminants in your drinking water may lead to health problems. This makes private well testing important for better health.

Testing is often not required but is encouraged because many contaminants may not cause any change in your water's taste, color, or smell.

WHAT SHOULD I TEST FOR?

The Wisconsin Department of Natural Resources (DNR) recommends these tests for common contaminants that can be harmful to human health:

Bacteria

- Test once a year
- Test any time the well is modified
- Test any time there is a change in smell, taste, or color

3 Arsenic

- Test when a new well is installed
- Test yearly if arsenic was previously detected
- Test at least once every 5 years

2 Nitrate

- Test once a year
- Test before a pregnant person or infant drinks the water

Resolution to Amend Resolution 41-2021 to Reflect Proration of Employer HSA Contribution and Opt-Out Incentive Payments

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting on this 21st day of March 2023, does resolve as follows:

- 1 **WHEREAS,** Resolution 41-2021 approves the pre-tax contributions for eligible enrolled
- 2 employees to establish an Health Savings Accounts (HSAs) and approves an annual
- 3 incentive payment to employees who opt out of health insurance benefits.
- 4 **WHEREAS,** the County's responsibility to make lump sum payments, per Resolution
- 5 41-2021, puts the County in an unfavorable financial situations. Examples of this
- 6 disadvantage include the ability of any employee to partake in both payouts or take a
- 7 payout and immediately resign from employment without penalty.
- 8 Fiscal note is not applicable.
- 9 Majority vote is needed to pass.

Section 2. Chapter 257, All-Terrain/Utility-Terrain Vehicles is amended as follows:

§257-1. Authority.

This Chapter is adopted under the authority granted by §§59.02 and 23.33 (8)(b) and (11) Wis. Stats. and Wis. Admin. Code NR §64.12.

§257-2. Title.

This Chapter shall be known as, referred to, or cited as the "Green Lake County All-Terrain/Utility Terrain Vehicle, (ATV/UTV) Ordinance."

§257-3. Jurisdiction.

This Chapter shall regulate the operation of all all-terrain/utility-terrain vehicles in all areas of Green Lake County.

§257-4. Adoption of Statutory Provisions.

Except as otherwise specifically provided in this Ordinance, the statutory provisions in Chapters 23, 340 to 348 and 350 of the Wisconsin Statutes, establishing regulations with respect to all-terrain vehicles (ATVs), utility terrain vehicles (UTVs) and Wisconsin Administrative Code Chapter NR 64, All Terrain Vehicles and Utility Terrain Vehicles are hereby adopted by reference and made a part of this chapter as if fully set forth herein. Unless otherwise provided in this ordinance, any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this ordinance. Any future amendments, revisions or modifications of the statutes or administrative codes incorporated herein are made a part of this chapter to secure uniform statewide regulation of ATVs and UTVs.

§257-5. Definitions.

A. The definitions of words and phrases as they appear in §§23.33(1), 340.01, 341.01, 342.01, 343.01, 344.01, 345.01, 346.01, 347.01 and 348.01 Wis Stats. and Wis. Admin. Code NR §64.02, unless the word or phrase is defined differently in this chapter, are hereby adopted and made a part of this chapter as if fully set forth herein. Any future amendments, revisions or modifications of the statutes or administrative codes incorporated herein are made a part of this chapter to secure uniform statewide regulation of ATVs and UTVs.

§257-6. Delegation to Highway Committee.

The Green Lake County Highway Committee ("the Highway Committee") is authorized to designate or rescind segments of Green Lake County Trunk Highways as ATV or UTV routes, in accordance with the provisions of §23.33 Wis. Stats., Wis. Admin. Code Ch. NR §64, and the provisions of this chapter.

Final approval of any ATV or UTV route shall be by the County Board of Supervisors enacting an Ordinance.

§257-7. Designation, Modification, Suspension and Termination of ATV/UTV Routes.

A. ATV/UTV routes and proposed routes on or across a County trunk highway shall be investigated and monitored to ensure that the ATV/UTV route has been authorized and that the ATV/UTV route does not adversely affect the use of the highway or unreasonably interfere with the peaceful enjoyment of private or public property.

B. The County Board of Supervisors may rescind or modify the designation of an ATV/UTV route by repeal of an ordinance granting final approval of the designation or by an enactment of an ordinance modifying the designation.

C. The Highway Committee may temporarily modify or suspend any designation of an ATV/UTV route.

D. The Highway Commissioner may, without prior approval of the Highway Committee, modify or suspend any designation of an ATV/UTV route whenever emergency conditions require closure, up to 120 days. The Green Lake County Sheriff may temporarily close any ATV/UTV route whenever emergency conditions require closure.

E. Upon County Board approval of a designated ATV/UTV route, the County Clerk shall immediately send a copy of the Ordinance designating the ATV/UTV route to the Wisconsin Department of Natural Resources, the state traffic patrol, the Green Lake County Sheriff and any law enforcement agency of each town, city or village having jurisdiction over any of the county trunk highways to which the ordinance designating the ATV/UTV applies.

F. The designation of any segment of a County Trunk Highway as an ATV/UTV route within an incorporated municipality shall become effective upon passage of this ordinance or until the municipality passes an ordinance restricting ATV/UTV routes through the municipality.

G. The following segment(s) of the Green Lake County Trunk Highway system are designated as ATV/UTV routes:

All county roads unless otherwise posted or noted herein.

§257-9. Maintenance of ATV/UTV Routes.

A. Designation of segments of the Green Lake County Highway System as
ATV/UTV routes does not impose upon the Green Lake County Highway
Department a greater duty of care or responsibility for maintenance of those
segments than for any other segment of county highway. Operators of

123 ATVs/UTVs on county highways designated as an ATV/UTV route assume all the usual and normal risks of ATV/UTV operation.

§257-10. Signage of ATV/UTV Routes.

A. The Green Lake County Highway Department is solely responsible for ATV/UTV route signing. All required designated ATV/UTV route signs shall be installed and maintained by the Highway Department.

B. All required signs shall be in accordance with state statutes and administrative codes applicable to ATV/UTV routes on County trunk highways.

C. No person may erect, remove, obscure, or deface any official designated ATV/UTV route sign unless authorized by the Highway Commissioner.

§257-11. Operation on All-terrain/Utility-terrain Vehicle Routes.

A. No person shall operate an ATV or UTV on a county trunk highway that has been designated by the County Board or municipality, to not allow ATV/UTV traffic, except for operation that is allowed under state statute or administrative code.

B. No person shall operate an ATV or UTV on a county trunk highway designated as an ATV/UTV route if the County trunk highway is closed for any reason.

C. General limitations. The following limitations apply on all county trunk highways designated as ATV/UTV routes:

1. Operators shall abide by all traffic laws unless further restricted by this chapter.

2. No ATV or UTV shall be operated at a speed greater than 35 miles per hour unless a reduced speed is otherwise required by state statute. [Amended 5-15-2018 by Ord. No. 21-2018]

3. All ATVs and UTVs must operate with fully functional headlights, taillights, and brake lights.

 ATVs and UTVs may only be operated on an approved ATV route between 5:00 a.m. to midnight, year-round (January 1 through December 31).
 [Amended 2-18-2020 by Ord. No. 3-2020]

5. All ATV or UTV operators shall ride in single file on the extreme right-hand side of the paved portion of the highway. Operation on the gravel shoulders, grassy in-slope, ditches, or other highway right-of-way is

- prohibited unless yielding the right-of-way. Left turns may be made from any part of the highway when it is safe given prevailing conditions.
 - 6. Crossings should be made only at a place where no obstruction prevents a quick and safe crossing. "Obstruction" includes, but is not limited to, impairment of view and potentially hazardous roadway conditions.
 - 7. All ATV and UTV operators and passengers under 18 years old shall wear protective headgear while operating on County trunk highways.
 - 8. No person under the age of 16 may operate an ATV or UTV on any segment of a County trunk highway that is a designated ATV/UTV route.
 - 9. Every person who operates an ATV or UTV on any segment of a County trunk highway which is designated as an ATV/UTV route shall have in his or her immediate possession a valid motor vehicle operator's license and shall display the license document upon demand from any law enforcement officer, state patrol officer, inspector under Wis. Stat. §110.07(1), conservation warden or municipal peace officer.
 - 10. No ATV or UTV may be operated on any designated ATV/UTV route if the ATV or UTV does not meet all applicable federal noise and air pollution standards.
 - 11. No person may ride in or on any part of an ATV or UTV that is not designated or intended to be used by passengers.

§257-12. Enforcement.

- A. This Ordinance shall be enforced by any officer employed by the Green Lake County Sheriff's Office, or any other law enforcement official as set forth in Wis. Stats. §23.33(12).
- B. Adoption of this ordinance shall not prohibit any law enforcement officer or DNR warden from proceeding under any other ordinance, regulation, statute, law or order that pertains to the subject matter under this chapter.

§257-13. Violations and Penalties.

Any person violating any provision of this chapter shall, upon conviction, forfeit a dollar amount not to exceed the maximum dollar amount of the forfeiture provided in the subsection(s) of Wisconsin Statutes violated, together with all applicable costs, and in default of payment of such forfeiture and costs shall be confined in the Green lake County Jail until such forfeiture and costs are paid, but not to exceed 30 days.

§257-14. Severability.






ATV on Roadway Study




Out of these on-road incidents in 2022, 5/10 with 3 pending were intoxicated. In 2021 16/30, 2020 12/24, 2019 14/14, and 2018 6 /12 with 4 pending on road incidents had intoxicated operators. Out of the 90 incidents in the last 5 years of fatalities recorded in Wisconsin, only 2 of these incidents had an operator wearing a helmet. The other 88 fatalities were shown to not have the proper protective gear while riding on the roadway. WISDOT's most recent data shows the breakdown of all modes of transportation fatalities within the state. The data are the most current and official numbers as there is some lag while investigations remain open in some cases. ATV data was added from the same date range as comparison with the DOT records for on road fatalities. (Wisconsin DMV Official Government Site - Final year-end crash statistics (wisconsindot.gov))



Out of the 404.98 miles in the municipalities of Green Lake County, 310.45 miles are now open to ATV's in the county. That's over ¾ already. With the likely opening of the Town of Berlin and Town of Seneca, that would make the total 362.98 miles open out of 404.98. Leaving the town of Marquette, Village of Marquette, and the City of Green Lake the only municipalities that remain closed to ATV traffic.



Opening up all county roads with the current municipalities that are open would allow for 487.1 miles open out of the 633.92 miles of roadway in the county. Opening the Town Seneca and Town of Berlin would put the county at 576.83 miles out of 633.92 miles in the county open to ATV.

Speaking with colleagues throughout the state, none have reported any issues with opening larger portions of their roadway systems. Most have said it has been seamless and a non-issue. Some counties have chosen to open 100% of their roads, others have opened all with some exceptions. Exceptions tend to be roads with heavy truck traffic, sections close to interstate highways, or some go off of ADT with the range being roads open from 1000 ADT or less all the way up to 2500 ADT or less.

The cost to the county for signage would be approximately \$8,774 to post proper trail signage. According to SS 23.33(9) there is funding available for the placement of signage to develop ATV routes. This comes out of the DNR vehicle registration fund. In addition, enforcement funding is available to help local enforcement agencies with the additional cost to enforce the use of ATV traffic on the roadway systems. There is also money available for training on how to enforce the ATV's on the road. This all comes from the DNR out of the vehicle registration fund and is available to local enforcement agencies.

There are plenty of reasons to update our ordinances to align with the current times in our world. Data shows no significant safety concern if all rules and guidelines are followed to allow ATV/UTV's on the roads. Riding an ATV/UTV on the roadway is safer than walking or riding a motorcycle according to the data. UTV's provide much more protection than walking, biking, riding a moped, riding a horse etc. They have full roll cages to protect the occupants of the machines.

ATV/UTV's are also much lighter than a car or truck. The average car on the roadway weighs 4,094 LBS. The average truck weighs somewhere between 6,000-8,000 LBS. The average UTV only weighs 1,400 LBS. That is less wear and tear on the road surface, base, and sub-base system. The tires are also much softer and less abusive to the surface of our roads. If someone wants to run to the grocery store or out to grab lunch and would rather take an ATV/UTV, why not let them? It's better for our road's longevity.

There is also the potential for increased revenue into the county and to our local businesses. With all of the outdoor activities such as hunting and fishing in the area, having the capability to run your ATV/UTV to the lake or woods would likely spread the income to the local businesses on the way as well. Grabbing supplies, food, fuel, and so on could potentially generate additional revenue in the county. Not to mention the scenery of Green Lake County bringing potential visitors to the area to ride and stay at local inns and motels.

By opening up all of our county roads to ATV's, in addition to the benefits of the general public, this will allow more time for the highway department staff to focus their goals on the important matters regarding the maintenance of our roadway systems. The amount of time wasted dealing with ATV permitting and mapping is simply not sensible and never recovered. This topic should undergo serious consideration and be put to rest.
