The regular meeting of the Health and Human Services Transportation Meeting was called to order by Chair Beuthin at 9:02AM on Wednesday November 16, 2022 in the County Board Room, Green Lake County Government Center, Green Lake WI. The meeting was held in person and via Teams. The requirements of the open meeting law were certified as being met. The Pledge of Allegiance was recited.

Bamberg reported on what the 85.21 grant is and that the funding has remained the same in the previous years. Discussion followed.

85.21 Specialized Transportation Association Grant Update

Motion/Second (Buss/Trochinski) to approve the 2023 85.21 Grant to be approved and submitted to the state as presented. All Ayes, motion carried. Discussion followed.

5310 Grant Update

Schuh reported and updated on the vehicles for the 2022 and 2023 cycle. In 2023 we are planning on receiving a medium bus pending WisDOT approval. The vehicle cost estimate is \$29,735 which has gone up dramatically. Schuh reported that DSI and GLC carryover funding will combine to cover the 20% match for that vehicle.

Schuh also reported on the 2022 minivan that was awarded for Southern Green Lake County. The vehicle price has gone from as estimated \$35,200 to \$67,546. The match we were supposed to come up with was \$7040, but now would be \$13,549. Additional costs to cover the price increase

could total \$32,546, for a worst-case scenario grand total of \$46,095. WisDOT has marked us down as needing more information before we decide on whether or not to procure this minivan for SGLCST. We are currently waiting on an answer on the actual total, this is still a work in progress between WisDot and the 85.21 Grant recipients. Discussion followed.

Schuh also reported on the operating funding for 2023. DSI asked for \$89,173. The typical award is between 40-60% of the ask. The grant amount has not been awarded for 2023 yet. Discussion followed.

Gas/Repair Costs

Schuh reported gas comes through the county highway department at \$2.402 diesel \$2.943 for gas. Discussion followed.

85.21 Specialized Transportation Funding

• 85.21 Specialized Transportation Funding is funding provided by the State of Wisconsin to Counties to provide specialized transportation for elderly and disabled individuals. Each year the County must write a grant and submit that Grant to the State by 12-31 to receive their allocation for the following year.

For 2023 Green Lake County's allocation is \$79,889.00. To receive our allocation Green Lake County must commit to spend a matching amount of \$15,978.00 in County funds.

Green Lake County then splits its 85.21 transportation dollars to fund 5 transportation programs in the County. They are: The City of Berlin; The City of Green Lake; The City of Princeton; Southern Green Lake County Senior Transportation; and Fox River Industries. These programs then provide the rides for elderly and disabled citizens. Green Lake County submits all required reports for the funding.

 - The review determined our vehicle insurance policy does not include WisDOT as an additional insured on the policy. They have no requirement to be added as co-insured; but instead, they are to be noted as the title holder.
