<u>140 Review Update</u>: Chris Culotta, NE Region Division of Public Health Director, presented certificate of designation as a Level II health department in the state of Wisconsin. Chris also gave an overview of the Foundational Public Health Services. Discussion followed.

2023 Quarter 1 Environmental Health Update:

- 11 pre-inspections
- 47 routine inspections
- 2 Complaint investigations
- 19 water test kits were given in O1
- 5 Housing inspections cases
- 3 Rabies/Quarantine cases

Partnering with Todd Morris from Land Conservation for groundwater testing program using ARPA funding for first 2 years. This is a continuation of the Well-water testing program with the Health Unit from 2019. Discussion Followed.

Community Health Assessment:

Initial Community Health Assessment meeting held on January 23rd with HCI Conduent to kick-start CHA process. HCI has helped us to develop surveys, collect and analyze data, as well as development of our CHIP. We have a steering committee that will oversee the CHA/CHIP process.

- Community Health Survey kicked off on March 8th both in online and paper forms. Paper surveys were distributed to all GL county libraries, mailed to all Amish households, and distributed out to focus groups we held. To date, we have received over 650 responses.
- Focus groups for Community Health Assessment held throughout the month of March. Locations included: Headstart, Boys and Girls Club, Manchester senior center, Princeton senior center, Dalton Midwives, Rivershores church, BHU staff/clients, and GLC inmates.

Quarterly Report on Health Unit Activities:

- Health Unit has been awarded \$8,000 in funding that had been requested through the Alliance for WI Youth (AWY) for 2023 to provide additional support to our permanent drug drop box sites, increasing Naloxone (Narcan) education in the community, and supporting a community event in partnership with our Overdose Fatality Review Team. Discussion followed.
- First blood drive held on January 19th with the Community Blood Center. Weather did play a factor in the number of donors who showed up, but they were still able to collect 17 units of blood which has the potential to save 51 lives. Discussion followed.
- Hazard Vulnerability Assessment for Green Lake County completed with EM Gary Podoll on January 30th. Information collected will be submitted to our HERC (Healthcare Emergency Readiness Coalition) coordinator, Tracey Froiland.
- 3 staff (Rachel, Allison, and Nancy) attended Preparedness Training on January 31st at the Fox Valley Safety Training Center in Appleton. Course title: MGT403: Underserved Populations Preparedness Planning for Rural Responders and Volunteers. Course is DHS and FEMA-certified.
- Amish home visits were conducted on Tuesday, February 7th. 8 families visited, 10 vaccines given, 3 water tests performed, and 4 car seats provided. Discussion followed.
- Health Officer Rachel Prellwitz and Tri-County Environmental Health Specialist, Jessica Jungenberg taught a class on Human Health Hazards to Alliant Energy staff.

- Diabetes Fair to be held in November with Lions Club at Grace Lutheran Church in Berlin.
- Collaborating with BHU on Zero Suicide initiative. Completed initial self-study for grant application on March 6th.
- The Green Lake County Diabetes prevention program (DPP) has submitted their 1st 6 months of data to the CDC. The evaluation report shows that the program is on track to attain preliminary or full recognition, potentially in six months. 

March 2023 Health Unit Monthly Report to the Health & Human Services Board

Public Health Update:

- Much of the focus for the month of March has been on our Community Health Assessment.
- All staff renewed CPR certifications on March 1st.



• Collaborating with BHU on Zero Suicide initiative. Completed initial self-study for grant application on March 6th.

- Community Health Survey kicked off on March 8th both in online and paper forms. Paper surveys were distributed to all GL county libraries, mailed to all Amish households, and distributed out to focus groups we held. To date, we have received over 650 responses.
- Focus groups for Community Health Assessment held throughout the month of March. Locations included: Headstart, Boys and Girls Club, Manchester senior center, Princeton senior center, Dalton Midwives, Rivershores church, BHU staff/clients, and GLC inmates.
- The Tri-County Overdose Fatality Review team continues to meet and work toward efforts that promote education/prevention/recovery/harm reduction related to substance use. Overdose deaths ARE preventable. In February, we completed our 10th case. We are in our final year of the first grant from OD2A and are in the process of transitioning into another 5-year grant! We are also looking at restructuring our team in order to gain better Tri-County data, recommendation and implementation practices. This brings opportunity for new members to join our team if you are interested in learning more, please contact Lisa Rollin at ling@greenlakecountywi.gov.
- Final strategic plan completed, reviewed quarterly by staff.
- Staff began course offered through University of Minnesota called, Systems Approaches to Healthy Communities, which is a requirement of our Maternal Child Health (MCH) grant.
- Maternal Child Health Summit Session 1 held virtually on March 15th. This is also a mandated activity through our MCH grant.
- Held 2nd Community Health Assessment Steering Committee meeting (both virtually and in-person) on March 15th in partnership with HCl Conduent.
- Fox Valley Healthcare Emergency Readiness Coalition meeting held on March 21st with PHEP coordinator Allison Krause attending.
- Allison Krause is participating in a State PHEP work group/advisory committee. She is helping to develop the new PHEP plan template that will be used by all local/tribal health departments.
- The Green Lake County Diabetes prevention program (DPP) has submitted their 1st 6 months of data to the CDC. The evaluation report shows that the program is on track to attain preliminary or full recognition, potentially in six months. This is important as it would allow the program to start the process of becoming a Medicare- DPP supplier, which would allow the program to bill for services, helping it to become a sustainable program.
 - We currently have 23 participants enrolled in 2 active cohorts, with a new cohort beginning on 4/18.
- Lauren attended the Northeast Region Alliance for Wisconsin Youth (AWY) meeting held on March 24th. The focus of this meeting was an update on Tobacco 21.
- Received approval of ARPA funding for Well Water Testing Project Collaboration with Todd Morris and Ken Bates. Campaign will focus on health-related concerns with high nitrates in drinking water and need to test water at least yearly. 150 free water test kits to be provided with focus on well located in the Townships of Princeton and Dalton.

CHILDREN & FAMILY SERVICES UNIT – March 2023

The children and family unit are fully staffed.

Out-of-Home Care – as of 04/01/2023

Foster Care – Level I & II (Range of costs from \$300.00 to 2000.00). At the beginning of the year, 17 (seventeen) children were placed in some form of out of home care; non-relative foster care, relative foster care or treatment foster care. However, 1(one) child's parent right's were terminated and she will be adopted in the future, four (4) returned home and two (2) reached permanency under guardianship to the grandparent.

We have two (2) children placed in a Green Lake County Licensed Foster home and seven (7) children are placed with their relatives that are licensed.

Treatment Foster Care – **Two (2)** children/youth are in treatment foster care through Pillar & Vine at this time.

We have eleven (11) children currently in out of home care.

Kinship Care – Voluntary (\$300.00 month per child) Six (6) children are in Kinship Care.

Subsidized Guardianship — Is considered a permanent placement for the children and the county must review the home and placement one time per year. We have two (2) subsidized guardianships.

Youth Justice:

Youth Justice staff have been working on groups for the school districts. They began a Vaping Curriculum group on March 29th that will last 6 weeks and 6 youth are participating in Berlin.

April 5th, a Vaping Group began in Princeton for 6 weeks, with 5 youth attending.

Girls Group continues to run with 2 youth attending.

Truancy Curriculum, "Showing Up", group began in March for 5 weeks with 4 females attending in Berlin.

Birth to Three/C-COP/CLTS

Birth to Three presently has had six (6) new children referred in the month of March. Four (4) new children were found eligible therefore, 4 new Individualized Family Service Plans (IFSP)'s were developed. Eleven (11) children were open in the program in the month of March. Children's Community Options has two (2) children enrolled. Children's Long-Term Support (CLTS) are presently being carried by the Birth to Three staff. Sixteen (16) cases have been assigned.





Performance Comparison by Month







Behavioral Health Unit—April 2023

Behavioral Health Unit programs continue to see caseload volumes at full capacity while we continue to recruit for and train new staff. At present, we have an open clinical therapist role. We have a new CLTS coordinator scheduled to begin in early May.

We are continuing to work through a series of upgrades to our electronic health record and are optimistic that these upgrades will benefit clients and streamline the work of administrative staff and practitioners.

Additionally, Medicaid has made several changes recently which will impact various programs in addition to the end of the public health emergency quickly approaching.

- Medicaid is implementing a new claim review process. While we are confident that our clinicians and
 administrative support staff do a fantastic job documenting, this will potentially generate some

 will tighten the timelines for clinicians' documentation.
- Medicaid is implementing a new set of codes for crisis response programs. This will pave the way for
 an incentivized rate to be paid for mobile and team-based crisis response in 2024. At this time, staff
 continue to work through the added training requirements, and administrative staff have been
 working to understand the new codes and ensure they are set up properly.
- As the public health emergency for MA/ Medicare ends in May, we anticipate that some insurance
 providers will no longer cover audio-only phone calls, leading to another shift in how telehealth is
 able to be used within the clinic.

<u>Outpatient Mental Health (MH) & Substance Abuse (SUD) Programs</u>- The majority of Behavioral Health clients are served via our outpatient clinic. The outpatient clinic serves clients' mental health and substance use disorder (SUD) needs.




Figure 1: Psychiatric services data have varied and declined after 2020. This is primarily due to the end of child psychiatric services at this agency with the retirement of Dr. Baldomero. Outpatient therapy services have declined due to having open therapy positions over the majority of the past year due to difficulties recruiting for qualified counselors and due to existing counselors splitting their time between outpatient and crisis services.

March Note:

1. Clinicians continue to have full caseloads, however as our therapy service team has been short staffed for much of 2022, outpatient service encounters have been fewer. We have noted modest improvement in our wait


time (average wait for an assessment is currently 37 days, average wait from intake to 1st treatment session is 23 days)—target would be 14 days or less. This wait time does continue to grow as we are still working to recruit a therapist for our open position.

- 2. The outpatient clinic continues to recruit for an additional full-time therapist position. Many Human Services departments across the state have had comparable difficulties finding qualified therapists.
- 3. Outpatient clinicians are preparing for documentation changes that have come as a result of the above noted Medicaid changes as well as completing training in relation to the upgrades to our health record system.

<u>Wrap-Around Services-</u> Behavioral Health Unit provides three tiers of wrap-around services, allowing us to match individuals with a program that meets the level of need based on their unique situation.

- 1. Targeted Case Management (TCM)— Less intensive case management for clients. **This program** expanded to include adult clients in summer 2018. It presently serves 11 individuals.
- Comprehensive Community Services (CCS)—Recovery-focused support for clients who may benefit from an
 intensive level of services for a shorter period of time. This program serves individuals across the lifespan
 and presently serves 42 individuals.
- Community Support Program (CSP)- Intensive community-based support for individuals with chronic mental illness. This support is intended to be long-term and supports clients to maintain psychiatric stability in the community and to reduce hospitalizations. This program presently serves 18 adults.

<u>Crisis Services</u>- Crisis services are available 24/7 including weekends/ holidays for psychiatric and substance use disorder emergencies



In March, we continued to see increase in crisis responses consistent with the past several years. Call volume has had an average of 30% increase since this same time in 2020. The data represent new crisis calls each month. The crisis team provides additional follow up services to clients after their initial contact. This differs case-by-case basis, however crisis follow up can last anywhere from 30 days to 6 months. In 2022, we received a crisis enhancement grant and are continuing to use this grant to explore ways that we can improve timely, mobile response to calls.

In January 2023, we added a crisis therapist position to our staff which has allowed us to expand outreach and offer more expedient follow up for individuals in a crisis who may otherwise have been on a waitlist. We believe that this, along with the integration of our substance use case manager position into the crisis enhancement team, has contributed to the reduction in emergency detentions so far this year compared to last year.

Our crisis team is applying to participate in the Wisconsin Zero Suicide initiative, a guided self-analysis process to review suicide prevention practices and ensure that they align with the best available practices and resources. Our team was notified that we were accepted to the collaborative and will begin participating in June. *Congrats Zero Suicide team!*

Children's Long Term Support Waiver (CLTS)—Medicaid waiver program provides funding for families of children with long-term disabilities (developmental, physical, and/or severe emotional disturbance) to access services such as respite care and service coordination which are otherwise not covered by Medicaid insurance. In 2018, Wisconsin announced the dissolution of the local waitlist and then subsequently the transition to a state-wide waiting list model and subsequently dissolved the state waiting list. Starting in 2021, youth who are screened eligible for CLTS services will automatically be placed into "enrollable" status with the expectation that the waiver agency will then open them within the allotted 30 days. In late 2021, we hired our first full-time CLTS case manager to attempt to meet the increasing need. Our current program census is at 47 youth. Our new CLTS case manager is scheduled to start employment on 5/8/2023. Welcome Ashliegh Gierke!
