Chair Gonyo adjourned the meeting at 9:44 AM.

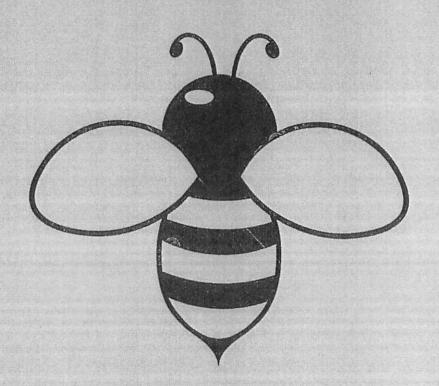

Hello Everyone,

It's been quite a while since I've emailed you all as a team on the Veleta et al case! I wanted to let you know that today, the final codefendant on the federal prosecution, Belter Arana Bautista, was sentenced. That means our case is now officially closed! Belter was a fugitive in Louisiana for a while, which is part of the reason why his sentencing just happened 3.5 years after the offense, but overall this case took a lot of time and effort from everyone! I wanted to write to acknowledge that fact and to thank you again for the opportunity to pursue justice where it seldom happens—on the demand side of trafficking. You should be very proud of your work!

Here are the sentences each of the federal defendants received:

 Oscar Martinez Corado: 24 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking

- Belter Arana Bautista: 24 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking
- Abilio Corado Gonzalez: 27 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking
- Samuel Martinez Corado: 28 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking
- Avelino Sarceno Sarceno: 30 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking and one count of Illegal Reentry
- Evis Garcia Rivera: 87 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking
- Julio Cesar Veleta Veleta: 87 months in prison followed by 5 years of supervised release on one count of Conspiracy to Commit Sex Trafficking
