On January 1, 2024, an inmate in the jail experienced severe emotions and felt the need to try and end his life. He ran to the second tier of his unit and tried to tie a sheet around his neck to hang himself from the second-tier railing. Due to quick actions of Sgt Samantha Koscher, CO Cody Wing, CO Cheyene Willie as well as two inmates they were able to stop him from accomplishing his goal. I feel that jail staff did an exceptional job when dealing with this incident. Their heroic actions saved this inmate's life.

I would like to recognize Sgt Samantha Koscher, CO Cody Wing, CO Cheyenne Willie for going above and beyond while on- duty that day. Not only did they save the inmate's life, but they also recognized the other two inmates' involvement for assisting them and put their needs above their own. They took the time to make sure they were ok and did an amazing job working together as a team. They showed exemplary care and concern for the safety of the inmates and didn't ask for recognition for themselves, but for the two inmates who assisted. That is how caring and compassionate they all are.

I believe it shows leadership, professionalism, and teamwork from all of them to make sure the inmates and jail staff were safe. I would like to recommend that Sgt Smanatha Koscher, CO Cody Wing, CO Cheyenne Willie all receive a challenge coin because that day was just that "A Challenge". They all went above and beyond and showed excellent strength, outstanding communication, and leadership skills. They are an asset to the Green Lake County Sheriff's Department, and I am proud to have them on my team.

I hope you will consider Sgt Samantha Koscher, CO Cody Wing, CO Cheyenne Willie for the Challenge Coin as it is very difficult to work in the jail on a normal day, but when having to deal with a suicide attempt it can make it dangerous and emotionally draining for staff. They all did an amazing job in keeping the inmates and Jail safe.
