GREEN LAKE COUNTY DEPARTMENT OF LAND CONSERVATION 2023 ANNUAL REPORT TO COUNTY BOARD OF SUPERVISORS Green Lake



Chapter 92 of the Wisconsin Statutes governs the Land Conservation Department. The Land Conservation Department provides engineering, technical design and conservation planning to landowners to help control soil erosion and protect water quality. The Land Conservation Department is under the supervision of the Land Conservation Committee. The mission statement of the Land Conservation Department is, "Our highest responsibility is to protect and enhance land and water resources that will sustain current and future generations."

DATCP Grant Funding Received

The department received a \$191,649 grant from the Department of Agriculture, Trade and Consumer Protection (DATCP) for departmental operations and program management.

Invasive Species Control and Education



In 2023, the Land Conservation Department signed a Lake Monitoring and Protection Network agreement with Golden Sand Resource Conservation & Development Council to provide technical assistance to communities, stakeholders, and volunteers within Green Lake County to prevent the spread of Aquatic Invasive Species (AIS), provide education about AIS impacts and prevention, and conduct lake monitoring. Activities completed through the network include AIS outreach, education, and display at Green Lake County Fair. Golden Sands RC&D conducted AIS response and monitoring of a butterfly dock population, assisted with Boat Wash Station setup, staff training, and end of year review, and coordinated and implemented the Purple Loosestrife Biological Control program in county.

Installation completed of Dodge Memorial Park boat wash station. A total of 315 boats went through the station to prevent the spread

of aquatic invasive species. Of the boaters that used the station, 86% said that they would use it again. Plans are underway to make the station automated in 2024 for 24-hour use.

Outreach was done through the state's Clean Boats, Clean Waters program. The Green Lake Association sponsored five Clean Boats Clean Waters inspectors at all eight public boat launches around Green Lake. Watercraft Inspectors completed 1043 hours at boat launches, contacting and inspecting 2679 boats.

County Lakes



Green Lake – We are in the second year of implementing the 9 Key Element Plan for the Green Lake Watershed. Through various funding sources approximately 603 acres of cover crops were established, 2 grade stabilization structures were installed, 3.2 acres of grassed waterways were established, no till practiced on 168 acres, and 11 acres of streambank buffers maintained in Green Lake County Buffer program (1.6 new acres in 2023.)

In 2023 the CAPTure[™] Pilot Project was completed. The goal of the project is to reduce the transport of soluble phosphorous to Green Lake. The reduction will be achieved by trialing a phosphorous filter system utilizing an iron-enhanced activated aluminum media capable of removing >50% of soluble phosphorous. While grade stabilization structures are effective at reducing sediment to lakes and stream,

they are not as effective at reducing soluble phosphorous. This project involved modifying an existing grade stabilization structure by updating the current inlet with a pipe drop structure and installing a drainpipe to flow the ponded water through the media. The CAPTure[™] project will be monitored for 2 years to determine phosphorus removal. If this project shows measurable soluble phosphorous reductions additional phosphorous removal systems could be retrofitted on similar projects throughout the watershed.

Lake Puckaway – The 5-year comprehensive lake management plan (2017) is currently being implemented.

In 2023 the Breakwater Restoration Project was completed. The former 1800's dredge banks provided protection to the variety of plants and habitats that are important for fish spawning, duck habitat, nesting of endangered tern species, and many other wildlife species. Large portions were eroded over the past 150 years. Restoration of the dredgebank will reestablish much of this vulnerable habitat and improve water quality.

As part of the Lake Plan development process, a plan was established to restore the eastern portion of the dredge to protect the habitat areas to the north side of the breakwater. Green Lake County Land Conservation worked closely with the DNR, Lake Puckaway District, Ducks Unlimited, the Corps of Engineers, and other partners to design, permit, and fund the restoration project.



Construction was scheduled for spring of 2023 with large barges that could complete the project within 3-4 weeks. Construction began May 1st and was completed by the end of the month. The project entailed placing more than 9,000 tons of rock on top of the existing dredgebank, covering 3,000 feet of restoration.

The Lake Puckaway District is also working with the DNR and private consultants to develop a 2023 Aquatic Invasive Species treatment plan.

Department of Land Conservation 2023 Annual Report

Twin Lakes – A Surface Water Grant Application was submitted on behalf of the Twin Lakes Association for the Big and Little Twin Lakes Aquatic Plant Management Plan Update. If successful in the grant allocation process, the Lake Association can update the Lake Management Plan to reflect current conditions, new management techniques, DNR recommended integrated management, and future management updates. The goal is for the Association to have a clear strategy and options for management activities.

Spring Lake (Green Lake Township) – A comprehensive Lake Management Plan was completed 2018, which will guide future management actions. The Land Conservation Department is working with watershed landowners to implement best managements practices identified in the Lake Management Plan.

Grand Lake – A Surface Water Grant Application was submitted on behalf of the Grand Lake Improvement Association for Curly-leaf Pondweed Control. The goal of this grant is to reduce curly-leaf pondweed populations recommended in the Associations Aquatic Plant Management Plan by carry out the remaining four years of their recommended 5-year treatments.

Little Green Lake - Little Green Lake Protection and Rehabilitation District is working on updating their Lake Management Plan. An application was submitted to Wisconsin Department of Natural Resources for Surface Water Planning Grant to fund the update.

Land & Water Resource Management Plan Implementation (DATCP)

In 2023, \$99,908 in state DATCP cost sharing was paid to 18 participants to implement various Best Management Practices (BMPs). Cost-share rates for these programs range from 50%-70% depending on the practice. Conservation practices installed/implemented under these programs in 2023 were:


Approximately \$192,158 was paid to landowners who installed/implemented practices in 2023. Thirteen new EQIP Contracts obligating \$217,000 were signed in 2023. Cost sharing for this program ranges from 50%-90% depending on the practice. Conservation practices installed/implemented in 2023 were as follows:

Farmland Preservation Program

This program's purpose is to preserve agricultural land and open space by promoting sustainable land use planning and development. A major component of the program requires landowners to comply with state soil and water conservation standards adopted by the Land Conservation Committee. Participants are eligible to claim a \$10.00 per acre income tax credit. In Green Lake County 268 landowners are eligible to received \$552,050 in state tax credits.



Green Lake County assisted landowners in the Town of St. Marie and Princeton in establishing Ag Enterprise Areas (AEA) in each township. The AEA's consist of contiguous agricultural that promote the same standards as the Farmland Preservation Program (FPP). The St. Marie AEA was established on 01/01/2021, and Princeton AEA was established on 01/01/2023, to date there are nine (9) landowners with a total of 1682 acres that have signed Farmland Preservation Agreements. Signing the agreement acknowledges that the landowner's intent is to keep their land in agricultural production for 15 years. The Farmland Preservation Agreement also makes them eligible for a tax credit of \$10.00 per acre.

In 2023 Green Lake County assisted landowners in the Town of Marquette in applying for the Agricultural Enterprise Area (AEA) designation. The Marquette AEA was selected to be approved as and AEA and became established as of 01/01/2024.

Clean Sweep


On August 11, 2023, 168 residents participated in a one-day hazardous waste chemical collection. The collection netted approximately 10,657 total pounds of hazardous waste. Also collected were 325 gallons of waste oil, 50 gallons of anti-freeze, and 2358 fluorescent light bulbs. A list of disposal options for items not collected at the clean sweep was distributed as needed.

In our eighth year of Electronic Waste Collection, we contracted with Resource Solutions Corp. D.B.A. RecycleThatStuff.com to collect our electronic waste. We collected 8154 pounds of electronic waste.

In addition, 403 tires were collected for a minimal fee. Liberty Tire Recycling was contracted to pick up and recycle the tires.

\$10,000 in revenue toward this event was received from Waste Management, \$12,710 in revenue was received from the Wisconsin Department of Agriculture, Trade, and Consumer Protection, and \$1686 was received for tire collection/waste oil/auto batteries. Total cost of the event was \$33,151 with the Green Lake County cost after all revenues and expenses of \$8755.

Land Conservation Ordinances



Construction Site Erosion Control and Storm Water Management Ordinance - In 2023, 14 Construction site erosion control and storm water management permits were issued, generating \$800 of revenue.

Animal Waste Management Ordinance – In 2023, 1 Animal waste storage facility permit was issued, generating \$200 of revenue.



Conservation Education Efforts

Poster Contest: The annual Conservation and Environmental Awareness Poster Contest for county students in grades K-12 was held in January with 93 poster entries received. Cash prizes were awarded to 15 students in various contest divisions. The award-winning students were recognized during the April County Board of Supervisors meeting. Award winning posters were also displayed at the Green Lake County Fair.

Arbor Day: The 2023 Arbor Day Breakfast celebration was held on April 28, 2023. This event was held at the Green Lake American Legion Post 306 with 85 participants. The featured speaker was Tony Johnson, UWEX Forestry Outreach Specialist who gave a talk on "Arbor Day Agroforestry."

Land and Lake Field Day: The Land and Lake field day was held at Boerson Farm on August 18, 2023. Topics included grazing and silvopasture, no till fresh market vegetables, conservation easements, and soil health with soil pit. The meal was prepared by local chef with ingredients from Boerson Farms. The Green Lake Association and Green Lake Farm Bureau sponsor the event while various agencies cooperate to make the field day a success for the 160 participants that attended.

No-till Drill Rental Program

The goal of this program is to promote the establishment of cover crops, small grains and forages, and native plantings using no-till planting. In this second year of the program the drill was leased to 24 landowners on a total of 379 acres. The various plantings were: 46 acres of native grass, 103 acres of forage planting (hayland), 114 acres of cover crops, 41 acres of no till soybeans, and 75 acres of small grains. We are looking to continue build on the success of this program in 2024.

Wildlife Damage Program

The Wildlife Damage Abatement and Claims Program is a program where, through local county implementation, farmers receive assistance with wildlife damage prevention and compensation for crops lost. This program is fully state funded with funds coming from a \$1 surcharge on hunting licenses.

2023 crop year deer damage claims of approximately \$49,714.97 was appraised for eight farmers. Eleven farmers received abatement assistance. Shooting permits were issued to farmers where over \$1,000 of deer damage occurred or was likely to occur with a total of 122 total deer harvested. USDA Animal, Plant, Health, and Inspection Service – Wildlife Services (USDA-APHIS-WS) handles day to day administration and field management with the Land Conservation Department having overall administrative and financial management. All staff and Land Conservation Committee time spent on this program is reimbursed 100% from the DNR.

In 2023, Green Lake County participated in the Deer Donation Program. This is the third year in which there was a specific drop off site established in the County. A total of 4 deer were donated and the Green Lake County food pantry received 300 pounds of processed venison.







Green Lake County Drainage Board

The Land Conservation Department assists the Green Lake County Drainage Board with projects and activities. The Board reimburses the Department for these activities.

District 1 – Inspection completed by Mr. Gneiser. There was an interest in having the ditch cleaned, but after further consideration by landowners, it does not make financial sense to clean it. The cost does not outweigh the benefit.

District 2 – Ditch remains in good working condition. The landowner keeps both District #2 and #3 in good order.

District 3 – Ditch remains in good working condition. The landowner keeps both District #2 and #3 in good order.

District 4 – No inspection completed.

District 5 – Inspection completed by Mr. Zietlow. Mr. Zietlow spoke with Mike Eagen on the phone and drain is operating good and there are no maintenance issues.

Seneca-Warren – Inspection completed by Mr. Zietlow, and Mr. Gneiser, landowner Lavern Alf was also present. Looked at areas along ditch that the side slope had washed out on (Alf and Schrock properties). These areas are planned for repairs. Looked at Abel property regarding withdrawal petition. Green Lake County Survey Grade GPS used to check elevations along ditch bottoms to determine flow direction. Lavern Alf mentioned that a corridor culvert should be installed in private lateral between his property and the DNR property for maintenance purposes. These culverts are 24" x 20' culverts. Follow up needed to survey washout areas and put design packet together for repairs. Crops are off in both spots so repairs can occur anytime conditions are right.
