### 2023 ANNUAL REPORT - CLERK OF CIRCUIT COURT

TO: The Honorable Chairman and Board of Supervisors for Green Lake County.

Please accept this letter as the annual report for the Clerk of Circuit Court's Office.

The office of Clerk of Circuit Court is the custodian of record. Record keeping for the courts is governed by state statute and Wisconsin Supreme Court rule. These require that clerks maintain records of all documents filed with the courts, keep a record of court proceedings and collect various fees, fines and forfeitures ordered by the court or specified by statute. A sampling of the responsibilities, but not inclusive, include:

File circuit court cases and provide proper case maintenance of said cases through the Wisconsin Consolidated Courts Automation Program (CCAP). This includes preparation of court notices and distribution; review files as to the status of each case; preparation of court orders/judgments at the direction of the Circuit Court Judge; receipt filing fees, fines/forfeitures, court costs, and various surcharges.

Clerk hearings - swear in all witnesses called to testify; follow through on any court orders/directives given by the Circuit Court Judge; mark all exhibits offered and received into evidence and maintain said exhibits through the appropriate appeal time period.

Jury - annual change in juror lists; summons jurors; prepare vouchers for payment of jurors, bailiffs, and misc. expenses; submit an annual jury analysis pursuant to Wisconsin Supreme Court Rule 73.01.

Miscellaneous responsibilities - file various tax warrants, liens, and satisfactions; monitor for collection reimbursements for Guardians ad Litem and Court Appointed Counsel; prepare monthly disbursements to the county and municipalities; prepare quarterly interpreter and juvenile reimbursement report; prepare annual restitution report to the State, and prepare an annual report of costs to the Supreme Court of Wisconsin.

### **DEPARTMENTAL COMMENTS**

### **JURY TRIALS**

This office sent out a summons for eighteen jury trials in 2023. Of this number, jurors reported for eight trials. Of these trials, two cases ended in a guilty verdict; three cases ended in guilty/not guilty verdicts; one case ended with an adjournment during trial; and two cases ended in a mistrial. Charges for these trials were 2<sup>nd</sup> Degree Reckless Homicide/Injury, Medical Malpractice, Intentionally Point Firearm at Person & Disorderly Conduct, 1<sup>st</sup> Degree Sexual Assault of a Child & Child Enticement, Criminal Damage to a Vehicle, OWI 3<sup>rd</sup> & Obstructing, and Incest with a Child by Stepparent. Five of these trials were multi-day trials.

The cost for these trials total approximately \$24,013.00. This amount includes per diem and mileage payments to jurors, payment of jury bailiffs, meals, and supplies. This also includes approximately \$9,600.00 in interpreter fees for two of these jury trials.

### **BUDGET CHANGE**

The Court Commissioner budget has previously been in the Circuit Court budget. Commencing in 2023, the budget of the Court Commissioner is now with the Clerk of Court. The State of Wisconsin supplies to Circuit Courts and Clerk of Courts across Wisconsin money to offset expenses of the counties. The payments are for court support and Guardian ad Litem fees. Each year, the State supplies two payments for court support and one payment for guardian ad litem. The Guardian ad Litem payment had previously been split 50/50 between the Circuit Court and Clerk of Court and the court support payment was split 2/3 to the Circuit Court and 1/3 to the Clerk of Court. Recently, the State has decided the payments would be in a lump sum payment. Judge and I agreed it would be easier to have the Clerk's office receive the full amount of these payments, instead of dividing it. The payment for 2023 was approximately \$76,000. To offset the revenue loss to the Circuit Court budget, the Court Commissioner expenditure was transferred to the Clerk of Court's budget.

### CASE COMPARISON & FINANCIAL INFORMATION

I have attached a 10-year case filing comparison. I have also attached financial information for 2023 that outlines costs and fees our office received, along with expenditures, payment received by the State of Wisconsin and payments collected for, and submitted to the State of Wisconsin, and to county municipalities.

My staff is to be commended for the excellent customer service provided in our, at times, hectic and fast-paced office and courtroom alike. Our goal is to continue to work together to provide this continued service and professionalism to the general public, and fellow County employees.

### CIRCUIT COURT | FAMILY COURT COMMISSIONER | REGISTER IN PROBATE 2024 ANNUAL REPORT

The Circuit Court is the trial court of general jurisdiction in Wisconsin. It has original jurisdiction in both civil and criminal matters unless exclusive jurisdiction is given to another court. It also reviews State agency decisions and hears appeals from municipal courts. Jury trials are conducted only in circuit court.

Although the annual report normally contains a list of the cases that have been handled by the Register in Probate and Juvenile Clerk, this year it was decided to show how busy Green Lake County is compared to surrounding counties. Attached are the filings for criminal, civil and divorce cases in Green Lake County compared to all of the surrounding counties. These three types of cases consume a large portion of the Court's time. Although other cases, such as small claims and traffic citations, are heard in circuit court most are not contested matters and do not consume as much time as those listed above.

Although all of the surrounding counties, with the exception of Marquette County (which is slightly smaller) are larger than Green Lake County, all of them (again with the exception of Marquette County) have more than one judge to handle the caseload in their respective counties.

The attached table shows the cases in each county and the number of judges in each county. Of importance is the break down of the number of cases per judge. This is done by simply dividing the total number of cases by the number of judges in the county. (Example, if a county with two judges had 600 criminal cases that would equate to 300 cases for each judge.

Dear Supervisors.

Please accept this letter as my annual report to the committee regarding the District Attorney's Office.

### Case Analysis:

1151 Referral cases (includes civil traffic/ordinance violations, review only, all criminal violations, death reviews, search warrants and any state civil prosecution (eg., open meetings complaints, DNR violations). The cases that stand out for purposes of public concern would be 155 drug related cases, 78 domestic related, 111 OWI cases, (civil felony and misdemeanor), 20 sexual assault cases, 18 gun related cases. We currently have 2 filed vehicular homicides and 3 filed Len Bias (drug overdose) homicides. Of the referrals received this year, 255 were felony case referrals, 410 misdemeanor were case referrals and 54 were juvenile delinquency case referrals.

In 2023, we received 20 less domestic related referrals, 22 less drug related referrals and 3 less sexual assault referrals. Significantly, in 2023, we received we received 35 more OWI referrals and 5 more gun related referrals.

Significantly, our referrals for drug related cases were down by 22 compared to 2022. However, we continue to do combat in the war against drugs. There were 18 cases involving methamphetamine, 10 involving possession of a narcotic drug (primarily heroin/fentanyl), 74 involving possession of THC and a handful of cases with various other types of drugs.

Four cases went to jury trial. These four cases involved convictions for Operating While Intoxicated 3<sup>rd</sup> Offense, Incest, 1<sup>st</sup> Degree Child Sexual Assault, and Child Enticement. Of note, there were 3 cases that we began trials but for reasons unrelated to actions by the prosecution mistrials were declared requiring new trial dates. This required significant work and resources to be utilized twice.

In addition to case filings, we assisted law enforcement with 70 search warrants or subpoenas in 2023. The majority of these search warrants involve either drug related offenses or sexual assault offenses.

### **Local Comparisons**

In 2023 our neighboring counties of similar size (Waushara/Marquette) had similar caseloads. Waushara County typically has a larger amount than Green Lake or Marquette and do have an additional prosecutor. They are also in the process of acquiring a second Judge.

### Filed Cases

Green Lake: Felonies - 159, Misdemeanors - 206, Criminal Traffic - 132 Waushara: Felonies - 256, Misdemeanors - 252, Criminal Traffic - 97 Marquette: Felonies - 134, Misdemeanors - 143, Criminal Traffic - 91

### Other

In addition we reviewed the following types of cases that had post-disposition activity: 8 Prison Petitions for Sentence Modification, 27 Sentencing After Revocation, 1 Parole Consideration, 1 Pardon Application.

The majority of our cases are being stored in an electronic format with the exception of some privileged and sensitive documents. This includes continuing to utilize an electronic referral procedure between all of our law enforcement agencies within the county. This is done with both Spillman (the law enforcement database) and Protect (the DA database) being linked. Protect is also connected with the courts database, also known as CCAP, which allows court filings to be done electronically as well. The trend we are seeing with respect to digital media is a move toward cloud based storage. This may require additional resources or the need for additional resources within our office.

Statewide prosecutors' offices continue to struggle to attract and retain attorneys due to non-competitive wages. This issue is an important public safety issue that must be addressed to ensure efficient and effective prosecution. Green Lake County is as vulnerable to this issue as any other county. Currently this is a statewide concern as there remain several vacancies, some of which have been pending for months.

In 2023, our office welcomed former Dodge County District Attorney, Kurt Klomberg, as our new Assistant District Attorney. Our team is now fully staffed. We are fortunate to have two prosecutors who each have decades of experience working alongside very experienced administrative staff. In 2024, we will look for opportunities to improve efficient work flow and processes that will enhance our existing victim sensitive and community accountable work.

### 2023 EMERGENCY MANAGEMENT ANNUAL REPORT

Director was awarded from the Federal Emergency Management Agency, the Emergency Management Planning Grant (EMPG) for director salary/operations of \$25,891.00

Director was awarded \$8,713.00 Emergency Planning & Community Right to know Act (EPCRA) Hazardous Material Grant.

Director was awarded \$7,234.99 Hazmat Response Equipment Grant for Hazmat Equipment for the Type II Team.

Director was awarded \$32,265.15 Hazardous Mitigation Grant for the 5-year update of the Green Lake County Mitigation Plan.

Director updated hazardous material plans for 11 facilities in the county, recorded updates of 43 reporting facilities and 12 Planning facilities.

Director has completed all state and federal requirements and has completed the planning calendar for next year.

Director is working on the County ID's using the State WI-CAMS System. There are a number of agencies in the county that are using the system. It is an on-going job to try and get as many people to use the system.

Director was put in charge by the County Board to work on the distribution of County ARPA Funds for 32 AED's that were placed throughout the County.

Director was put in charge by the County Board to work with County Fire Departments in the distribution of County ARPA Funds that the County Board approved to the Fire Departments. There are 3 Fire Departments left to purchase their equipment.

Director attended National Weather Service (NWS) Tornado Spotters training on April 10, 2023 held in the Green Lake County EOC.

Director held Local Emergency Planning Committee (LEPC) meeting on September 26, 2023 to go over hazardous material updates required by EPCRA and grants, which was completed and approved, by the state. Director is working with LEPC on local hazardous material issues, which pertain to Green Lake County. Director and LEPC have been working on county disaster exercise planning.

Director completed the following training, which included a WebEOC Drill and attending sessions at the Governor's Conference on Emergency Management and Homeland Security. This is a requirement for my State and Federal grants.

Director was notified of 41 Severe Weather statements, 2 Severe Thunderstorm Watches, 4 Severe Thunderstorm Warnings and 1 Tornado Watches and 0 Tornado Warnings that affected Green Lake County. Director was notified of 6 small Hazardous Materials spills and 1 large spill involving gasoline which occurred in Green Lake County. Director received 6 through the state reporting system and 1 through the Green Lake County 9-1-1 Dispatch Center.



Director hosted Tornado Spotter Training, put on by the National Weather Service on April 10, 2023 in the Green Lake County Emergency Operation Center (EOC).

Director is on call 24 hours a day 7 days a week.
