ORDINANCE NO. -2024

Ordinance to Amend §257-7, Designation, Modification, Suspension and Termination of ATV/UTV routes.

The County Board of Supervisors of Green Lake County, Green Lake, Wisconsin, duly assembled at its regular meeting begun on the 18th day of June 2024, does ordain as follows:

**NOW, THEREFORE, BE IT ORDAINED**, that the Green Lake County Highway Committee, from time to time, may review ATV/UTV routes on County Highways so as to facilitate the free flow of traffic without compromising the safety of motorists, pedestrians and residents.

**NOW, THEREFORE, BE IT ORDAINED**, that § 257-7 shall be amended as follows:

**A.**

All County Highway Roads Except the following segments shall be designated as ATV/UTV routes:

**(3)**

CTH F: Intersection of F and ~~CTH D~~ **N Fountain Rd** east to Berlin city limits; Berlin city limits south to Town 69 Line Road.

Commissioner and Chairman,

I should also add that the average citations issued in a year county wide is approximately 1500. The average warnings issued in a year county wide is 2000. With that in mind, you can see that this area gets significant enforcement. In the neighborhood of 5% of all citations and warnings for the report provided. There are some violations listed that are East of Berlin on CTH F, but even with that consideration, the enforcement is very significant.

If there are any other statistics that you believe would be beneficial to this discussion please let me know.

In some ways it is unfortunate, but truly impossible to know how many accidents **DID NOT** happen because of things like enforcement, presence, highway design, and laws limiting access. Somehow, someway I need to find a way for the Committee to understand this. Our traffic enforcement efforts are focused on preventing crashes that cause property damage, injury, and death. In this discussion and all discussions surrounding matters that involve highway traffic safety, I feel as though I am the only voice for safety. Had I not been alerted to the amended agenda that included this topic, there would have been no discussion regarding safety. The direction of the committee is apparent when there is a motion to open a section of roadway before any matters of safety are discussed or evaluated on an agenda item that is set for discussion only. While I understand that there is a significant responsibility of the Highway Committee to oversee operations, budgets, and prioritized needs, I also think that the safety element of many decisions needs to be a higher priority amongst this committee.

Chairman Mulder,

In my time as Chief Deputy I have seen you carefully deliberate differing viewpoints in an effort to thoroughly evaluate what is best for Green Lake County. I have seen you change your viewpoint based on information you receive at a meeting. This is commendable, and not necessarily a common trait. I am hopeful that in this circumstance and other similar situations you will lead this committee in a way that considers more strongly the safety impact of the committee's decisions,

and generally slow down the actions of the committee to allow the retention of facts and data that can be applied to whatever issue is at hand. The Sheriff's Office should not be viewed as an adversary to the Highway Department or the Highway Committee. We are a resource that can gather information and provide insight from other perspectives that may well add to your discussion to make informed decisions in certain circumstances.
