- a) Frost (BOTS)- Gave PowerPoint presentation.
 - Presented Year-to-Date traffic crashes and fatalities in Wisconsin.
 - (i) Total traffic fatalities for 2025 in WI is 448, compared to 452 at this time last year in 2024.
 - 2025 GLC crashes-
 - (i) YTD 2025 Fatal Crashes: 3
 - (ii) YTD 2025 Injury Crashes: 77
 - (iii) YTD 2025 Total Crashes: 292

- Gave overview of GLC crash predictive analytics and crashes by severity/driver behavior for 2025 vs. 1 year average.
- National Move Over Day observed on Saturday, October 18, 2025.
- Community Maps Virtual Office Hours will be every 2nd Monday of the month from 12-1pm via Zoom.
- Update on Law Enforcement Phlebotomy Program. Classes in January and May 2026 being held in Madison.
- Shared information on upcoming WI Spring DRE (Drug Recognition Expert) School class starting in March of 2026.
- Legislative Updates available under TSC resources via Community Maps.
- Provided contact information for the Bureau of Transportation Safety Team.
- Spoke on WI Traffic Safety Challenge that was presented on at the Governor's Conference on Traffic Safety. Traffic Safety is a Public Health issue. WI DOT is looking into the Safe System Approach.

- Current & upcoming projects-
 - (i) Update on CTH AW to CTH I Project is complete. Project involved a 4-mile pavement rehabilitation.
 - (ii) STH 44 resurfacing project from Grand River bridge to Fond du Lac County line. Project is ongoing and is expected to be complete in 2025.
 - (iii) Upcoming projects 2026- STH 23 (CTH A to Fond du Lac Co line)- 4.6-mile pavement mill and resurface project. Work is scheduled to occur in the summer of 2026.

 - CTH GG & CTH H finishing up this project

- c) CTH A and CTH K and Scott Hill intersection quarterly update.
 - No crashes since July 1, 2025 at this location.
