2024 KENNEL LICENSE FEES

Owners with 5 or more dogs are required to purchase a kennel license. Cost for kennel license is \$35.00, up to 12 dogs. An additional \$3 fee per dog is required for more than 12 dogs

DOG/KENNEL LICENSE INSTRUCTIONS

Mail application, check payable to Town of Manchester, copy of rabies certification for each dog, and self-addressed stamped envelope to:

All dogs, over five months, are required to be licensed and vaccinated for rabies by March 31 of each year. A late fee of \$20.00 will be assessed for failure to obtain a dog license after March 31
