- The Village Board meets the 2nd Monday of every month at 7:00 PM. Minutes of Village meetings and all other pertinent information are posted at the Post Office, Bank and Village Hall.
- There is no overnight parking on Village Streets from November 1<sup>st</sup> through April 1<sup>st</sup>. Property owners are responsible for keeping sidewalks free of ice and snow. Sidewalks must be cleared of snow and ice by 10:00 am or within 3 hours of daylight after snow stops. REMINDER...it is illegal to shovel snow into the roadway once the plows have already plowed the street.
- Remember...garbage is picked up weekly on Tuesday unless Monday or Tuesday is a Holiday then it is picked up on Wednesday. Recycling is picked up every other Tuesday. Recycling is MANDATORY in the Village. If you need a recycling cart, please notify the Village office. Recycling carts are the property of Waste Management and must be left at property when moving. Fall and Spring clean up will be provided for large, non burnable items. Dumpster is located in the old landfill site on Mill St. Village will notify you of the dates
- Building permits are required any time the outside dimensions change or ANY remodeling is done that exceeds \$2500.00. A building permit is required with new construction of a building; ANY SIZE...ANY COST.
- REMINDER...there is a dog ordinance in the Village. No dogs will be allowed to run at large and must be on a leash if off the property. Dogs running loose can be impounded and any costs will be paid by the owner. Also, per State Statutes, it is unlawful to keep any dog 6 months of age or older without licensing or harbor or keep a dog which habitually pursues any vehicle on any public street or assaults or attacks any person. Please notify Clerk if you need a license. PLEASE clean up after your pets!!!
- Green Lake County has a Medical Drop Box located in the front foyer to the Green Lake County Government Center, County Road A, Green Lake. Medical drop boxes collect unwanted pharmaceuticals from the public in an attempt to remove them from our natural environment and the environment of others who's unprescribed use would be dangerous and illegal. It is available 24/7.
- I will be collecting taxes and issuing dog licenses at the Village Hall on the following dates: (or by appointment or anytime I am working at the hall.) Payment by credit card is not accepted by the Village of Kingston.

December 28<sup>th</sup> from 10 AM-12 NOON

December 30<sup>th</sup> from 12 NOON-3 PM

January 31<sup>st</sup> from 12 NOON-2 PM

If you prefer, you can mail or deposit your tax payment in the sewer drop box in front of the Village Hall. Please enclose a stamped, self addressed envelope if you would like a receipt. If you need a dog license, please fill out the form on the back and mail or drop in the sewer drop box and I will mail your license(s).

## DOG/KENNEL LICENSE INFORMATION

Cost of a dog license is \$3.00 for spayed or neutered and \$8.00 if not spayed or neutered. Failure to obtain a dog license is subject to a citation from the Green Lake County Sheriff's Department. The fine for an unlicensed dog is \$150.00 per dog. The fine for an unvaccinated dog is \$150.00 per dog. For your own protection, **get your dog licensed and vaccinated**. Homeowners, PLEASE pass this information along to your renters.

**State Law** requires the rabies certificate be submitted with your payment. I CANNOT by law license any dog without it. If the rabies certificate cannot be found, contact the vet that administered the vaccination and ask them to send you a copy of the certificate. Payment for license will be sent back if a current rabies certificate is not enclosed and the dog will be listed as unlicensed and will be turned over to the County.

**KENNEL LICENSES:** The County requires anyone with 5 or more dogs to obtain a kennel license. An inspection of the kennel must be completed and passed before tags can be issued. An inspection report and proof of vaccination must be submitted when applying for tags. Please contact the Tri-County Environmental Health Consortium to schedule an inspection.
