**APPROVAL OF 08/19/2024 CANVASS BOARD MEETING MINUTES**

*Motion/second (Sonnleitner/Esslinger)* to approve the 08/19/2024 Canvass Board meeting minutes. Motion carried with no negative vote.

The tally sheets and poll lists were inspected for each municipality in Green Lake County.

Town of Berlin had 790 voters. Poll book reads 791, however a voter spoiled two ballots and decided not to vote while given the third ballot.

Town of Brooklyn had 1362 voters. They had one provisional ballot, but person did not return. Ballot does not count.

Town of Green Lake had 823 voters.

Town of Kingston had 326 voters.

Town of Mackford had 314 voters.

Town of Manchester had 419 voters. Trump got an extra vote due to his name being a write in vote.

Town of Marquette had 353 voters.

Town of Princeton had 1093 voters. Trumps vote count should be 717, not 117. Total was entered wrong.

Town of St. Marie had 260 voters.

Town of Seneca had 237 voters.

Village of Kingston had 204 voters.

Village of Marquette had 122 voters. Discussion held about ballots being mixed up between Village of Marquette clerk, and Town of Seneca clerk.

City of Berlin had 2656 voters. Poll book reads 2657 voters. However, in the inspector's statement, they explain that the machine was getting paper jams and counting more votes that it should have, making the total voters 2655. City of Berlin also had a provisional that was counted, making the total voters 2656. The provisional did not vote for county items.

City of Green Lake had 690 voters.

City of Markesan had 758 voters.

City of Princeton had 689 voters. Provisional did not come back. Voter does not count.
