I Thomas G. Wastart II, being the duly appointed Medical Examiner of Green Lake County, do request the County Board of Green Lake County authorize the attached invoice to be paid in full for the services provided by Steinhaus Holly Funeral Home per the request of the Medical Examiner for the final disposition of Steven L. Williams who died at Julliette Manor located in the City of Berlin, County of Green Lake on December 22, 2024. This request follows Wi. State Stats. 979.09 As copied in this request.

Per State Statue 979.09 "the coroner or medical examiner shall cause the body to be decently buried or cremated and shall certify to all the charges incurred in taking any inquest by him or her and to the expenses of burial or cremation of the dead body. The charges and expenses shall be audited by the county board of the proper county and paid out of the county treasury."

History: 1983 a. 279 s, 14: Stats.1983 s. 979.09: 2001 a.61.

I certify these charges are accurate and reasonable for the purpose of the county to provide for a responsible and respectful final disposition of Steven Williams.

These costs do not exceed the fee as defined in Wisconsin funeral and cemetery aids program administered by the State of Wisconsin. Steve Miller did not qualify for the WFCAP program and therefore became the responsibility of the County.
