ELECTION OF CHAIR AND VICE CHAIR

No action or discussion taken – both offices are voted on in even numbered years.

LAND INFORMATION MEMBER APPOINTMENTS

Discussion held regarding the appointment of committee members. Matt Kirkman will check with Corporation Counsel to find out if the appointments are mandated by statute.

APPROVE MINUTES FROM 09/11/2024

Motion/second (Thiem-Korth/Lenz) to approve the minutes from the September 11, 2024 meeting with no errors or corrections. Motion carried with no negative vote.

PUBLIC COMMENTS – none

2024 GRANT REPORTS

Jerry Stanuch presented the 2024 revenues in the amount of \$111,392 and the expenses totaling \$115,285. *Motion/second (Thiem-Korth/Shadick)* to approve the report. Motion carried with no negative vote.

2025 GRANT PROJECTS

- **PLSS**
- **New Aerial Image**

Jerry Stanuch stated that the PLSS project should be finished in March of 2026. There are 35 more corners to complete of the 1861 total. Stanuch showed pictures of the new aerial images and the difference in the resolution from 6” to 3”. This has been completed.

2026 GRANT PROJECTS

- **LiDAR** – Stanuch showed the difference between QL2 (our current program) to QL1 which is a higher resolution. Approximately \$17,460 would need to be paid for out of this grant because the rest would come from other grants.
- **ROD Media Conversion** – Stanuch stated that approximately \$40,000 would be needed from this grant to complete the project. ROD Renee Thiem-Korth explained the project.
- **Mobile Exhibit Trailer** – Stanuch and Todd Morris stated this would be for an outreach trailer shared with the Land Conservation department.

Motion/second (Thiem-Korth/Kirkman) to approve the grant application for \$72,776 and to use \$6,000 in retained fees for the exhibit trailer. Motion carried with no negative vote.

FUTURE PROJECTS

- **Block Corner survey**
- **PLSS perpetuation**
- **County Highway ROW survey**

Jerry Stanuch explained the possible projects for 2027. Discussion held on surveying costs for Dodge Memorial Park. Any other ideas should be given to Stanuch.

PROGRAM FUNDING INCREASE

Jerry Stanuch stated that the state of Wisconsin is proposing increases to the grants in the coming years. This is for informational purposes only.
