Interim County Manager Jason Jerome expanded on the new position and stated this person will be reporting to the Land, Water, Parks & Community Committee. Mary Neubauer provided background on the formation of the EDC and questioned the need for it's continued existence due to changes in funding, grants, etc. Liz Otto will check into the process for disbanding the group and report back at the next meeting.
