POSSIBLE RED FLAGS OF HOUSING DISCRIMINATION

People with disabilities

- The complex or condominium is not physically accessible to you.
- You tell a housing provider you have a service or emotional support animal, then are told "no pets" allowed.
- Your housing provider ignores or denies disability-related requests.

Homebuyers or homeowners

- A real estate agent shows you homes only in certain areas, ignoring your stated preferences about neighborhoods or areas you'd like to visit.
- A lender refuses to make a loan or charges higher rates due to the neighborhood where the home is located.
- An insurance agent tells you your home isn't eligible for coverage based on its age or its value.



Animals, fair housing and you

KNOW YOUR RIGHTS!





Do you need a service or emotional support animal due to a disability?

Request an accommodation for a service or emotional support animal

Steps to think about before bringing an animal home

Fair housing laws require, in most situations, housing providers allow residents with disabilities to live with service animals and emotional support animals.

Housing providers may charge extra fees and/or deposits for pets. However, they **may not** charge extra fees or deposits for service or emotional support animals.

EVERYONE HAS

To make a successful request, keep these key points in mind:

- You must have a disability.
- The animal must be necessary to help you have equal opportunity to use and enjoy your housing.
- The request must be a reasonable one.
 What is 'reasonable' depends on the specifics of your situation.

IF YOU MAKE A REASONABLE
REQUEST FOR A SERVICE OR
EMOTIONAL SUPPORT ANIMAL
AND YOUR REQUEST IS DENIED,
OR IF YOU HAVE ANY QUESTIONS
ABOUT THE ISSUE, CONTACT US.

- Determine the type of animal that will meet your needs.
- about your housing provider about your situation and seek their agreement. Typically, it is helpful to put your request in writing and to keep a log of your interactions with your housing provider.
- You may be required to provide verification of your disability as well as your need for an animal. You can get verification from various sources, including physicians, social workers, or mental health providers. For more information about additional types of verification sources, contact the Fair Housing Council.

Housing providers may include condominium associations, rental owners and managers, real estate agents/brokers, and others involved in the sale, management, and rental of housing.

Where you are from, what you believe, or who you are shouldn't affect where you can live. Housing discrimination based on religion or national origin is illegal. If you believe you have been treated unfairly when renting, buying, insuring, or financing a home, the Fair Housing Council is here to protect your rights.

Red Flags of Religious or National Origin Discrimination

Hate and Harassment

Screening Criteria

- Asking for proof of citizenship based on how you look, talk, or dress.
- Denying housing or services because you speak a language other than English.
- Refusing to allow an interpreter or translation of documents.
- Asking you to remove religious or cultural clothing, not allowing you to display religious or cultural symbols, or preventing you from engaging in religious rituals or cultural customs.
- Treating you differently than other residents by enforcing rules more harshly, charging higher fees, or limiting access to amenities.
- Denying your application or discouraging you from applying due to your religion or national origin.
- Restricting you to certain neighborhoods or buildings based on your religious or cultural affiliation.

If you feel unsafe or unwelcome in your home due to hateful incidents caused by your housing provider or other residents, these actions could be discriminatory. Red flags of hate and harassment include:

- Using slurs or derogatory language.
- Using hateful symbols or images, or distributing materials with hateful messages.
- Threatening to report you to the authorities.
- Vandalizing your property.
- Stalking, taking photos or videos of you without permission.

It is customary for housing providers to request information related to identification, income, credit, and rental or criminal history. However, if you are asked about your cultural background, religious beliefs or practices, or other personal details about your family, that could be discriminatory.

If you are a new immigrant or refugee and you do not have the type of documentation that a housing provider typically requires, you may ask whether they would be willing to accept alternative forms of documentation to provide proof of identification, income, and background.

If you have experienced discrimination because of your religion, national origin, or other protected class, contact the Fair Housing Council for help.



Fair housing laws prohibit discrimination against households with children



KNOW YOUR RIGHTS!

POSSIBLE RED FLAGS OF HOUSING DISCRIMINATION

A housing provider tells you:

- Your family is too big for an apartment.
- Babies can't sleep in your room.
- Children can't share a bedroom.
- Families can only live in a first-floor unit.

Housing providers may not use restrictive occupancy standards in order to discriminate against families with children.

The federal government prohibits housing discrimination based on sexual orientation and gender identity. Have you been treated unfairly in a housing situation?



KNOW YOUR RIGHTS!

POSSIBLE RED FLAGS OF HOUSING DISCRIMINATION

A housing provider, real estate agent, lender, appraiser, or insurance agent:

- Denies you housing because the name on your application doesn't match your ID, even when you explain why.
- Refuses to use your correct pronouns or name.
- Refuses to consider your spouse's income to determine eligibility.
- Harasses you or allows neighbors to harass you due to your sexual orientation or gender identity.
- Asks questions that seem unusually personal or invasive.
