#### **2026 FUEL PRICE REVIEW**

This bid pack is much more extensive than the first one so the committee should determine how they want to go through it. Mashuda Contractors has begun the site clearing. Footings could be started by the end of November. The plans for the salt storage sheds have been adjusted from 2 buildings down to 1. Several people were in attendance to ask questions but were advised to contact their County Board supervisor because the public comment portion of the meeting has passed.
