

### 2025 TAXES PAYABLE IN 2026

**Taxes are to be paid and mailed to: CITY OF GREEN LAKE**  
**(PLEASE DO NOT INCLUDE DOG LICENSE FEES WITH YOUR TAXES)**

Make your check payable to the **CITY OF GREEN LAKE** (Do not send the first payment to Green Lake County. Second payment still goes to Green Lake County Treasurer.) Send your payment, along with the tear off stub from your tax bill, to: City of Green Lake, PO Box 216, Green Lake, WI 54941. Include a self-addressed stamped envelope if you want a receipt returned to you. If a self-addressed stamped envelope is not included, your cancelled check is your receipt. Or hand deliver your payments to 534 Mill Street. There is a drop box in the outside lobby for your use outside of business hours. Payments received in 2025 will be dated as such. City Hall will be closed on December 24, 25 and 31, 2025 & January 1, 2026, due to the holidays. Please mail your payment in advance if you would like a receipt dated for December 2025. **NEW PROCESSING TIMES BY THE POST OFFICE REQUIRE PAYMENT MAILED BY 12/29/25 TO BE COUNTED FOR 2025 PAYMENT AND 1/28/26 FOR 1<sup>ST</sup> INSTALLMENT.** Normal hours are Monday through Friday 8:00 am to 4:30 pm. Credit and Debit cards are accepted for payment of taxes. There is a fee for this service. Go to [www.cityofgreenlake.com](http://www.cityofgreenlake.com) and enter your tax parcel number for the account number. Be sure to review the information on back side of your tax bill. All property owners eligible for lottery credit should verify status on their tax bill.

- All dogs kept in the City of Green Lake that are over 5 months of age must be licensed per State law. Licenses are valid for one (1) calendar year (January to December)
- Fees are \$10.00 for neutered or spayed; \$15.00 if not neutered or spayed. After March 31, a \$5.00 late fee is charged.
- Make check payable to "City of Green Lake" and send to City of Green Lake, PO Box 216, Green Lake, WI 54941. **Please do not include the fee with your tax payment**
- Enclose a copy of the rabies vaccination certificate for each dog and a self-addressed stamped envelope for us to return tag(s) and receipt(s) when applying for license through the mail.
