MINUTES

Motion/second (Schweder/Buss) to approve the minutes of the 11/12/2025 meeting as read with no errors or corrections. Motion carried with no negative vote.

PUBLIC COMMENT (3 minute limit) – none

REVIEW AND APPROVE BID PACK #2 FOR NEW HIGHWAY FACILITY

Highway Commissioner Derek Mashuda presented the bids received. Discussion held regarding the lowest bids versus vendors that coordinate with Government Center systems for maintenance purposes. Mashuda stated that bids came in under budget at \$32,600,000. Committee agreed by general consensus to approve each bid separately and to postpone approval of the HVAC bid and the electrical system, specifically the security system, until determining if the vendors coordinate with the Government Center systems. Some bids need to be redone due to no bonding or no bid received.
