****The US Post Office has a new rule about when letters are postmarked. COLLECTION TIMES – BERLIN TOWN HALL (Corner of Willard Rd & Hwy 91)

I will be at the town hall on Mondays and Thursdays from 10:00 a.m. until 2:00 p.m., Wednesdays from 12:30 p.m. until 4:30 p.m.

Saturday **January 31, 2026** 9:00 a.m. to 12:00 p.m.

***The office will be closed on Thursday, December 25th and Thursday, January 1st.**

Payment by mail is very much appreciated! If you choose to pay in person at the town hall, please make payment by personal check, money order, cashier check or escrow check. There is a debit (minus) figure next to the Town of Berlin's portion of taxes. **This is a credit!** The funds for operating and maintaining our Township is derived from the Valley Trail Landfill's tippage fees, so there is no township tax. Also, the township has set aside a school tax relief fund, a portion of this fund is the credit on your taxes listed next to the townships net tax.

Because of this all of your tax payments are for the state, county and schools, **the township does not receive any of your tax dollars.** If the town did not operate on the landfill's tippage fees, a tax would need to be collected from you the taxpayers.

DOG LICENSE APPLICATION

Male or Female \$ 8.00

Neutered or Spayed \$ 3.00

Multi-Dog License \$35.00 (over 12 dogs, additional \$3.00 fee per dog)

A LATE FEE of \$5.00 per dog for individuals & \$10.00 from each dog kennel operator will be collected for any license obtained after April 1st of the license year.

Please let me know if your dog license fee is included in your tax payment.

The STATE LAW requires the rabies certificate be submitted with your payment. I **CANNOT**, by law, license any dog without it. I will return the certificate to you. Please file for safe keeping for the required one or three years.

Green Lake County passed an ordinance that a single owner having possession of five or more adult dogs shall be required to obtain a kennel license (multi-dog license). Kennels licensed by the state must have an inspection performed by DATCP based on DATCP's requirements. Kennels not licensed by the state must have an initial inspection prior to the first kennel license by the local health department.
