2025-2026 Real Estate Tax payments are due by January 31st, 2026

PAY BY MAIL

- Include Tax ID Number.
- If paying more than one parcel with one check, list the Tax ID numbers and amounts for each parcel.
- Mail to the address listed on your tax bill.
- Include stamped-addressed envelope if receipt is required.
- Receipts received in 2025 will be dated as such. Please mail your payment in advance if you would like a receipt dated in December 2025.

PAY IN PERSON AT THE TOWN OF BROOKLYN TOWN HALL, located at N5988 County Road A, Green Lake WI

- Bring your tax bill(s) with you.
- Make checks or money orders payable to the Town of Brooklyn Treasurer
CASH WILL NOT BE ACCEPTED, NO EXCEPTIONS
- There is a drop box for use located at the Town Hall west entrance. **Drop box is for tax payments ONLY.**

NEW THIS YEAR!! Treasurer In-Person collection hours can be during office hours Monday and Wednesday from 10:00 AM until 1:00 PM. The town office will be closed from December 22, 2025 until January 2, 2026. The town will also be having after hours in-person collection on the following days: Wednesday, December 17, 2025 from 3:00 PM until 6:00 PM

ELECTION SCHEDULE for 2026

Tuesday, February 17- Spring Primary (if necessary) nonpartisan primary is held the third Tuesday in February to nominate candidates to be voted for at the spring election.

Tuesday, April 7- Spring Election – election held the first Tuesday in April for Court of Appeals Judge, Circuit Court Judge, County Nonpartisan Offices, Municipal Offices, School District Offices, and referenda (if necessary), and in Presidential years, to express preference for the person to be the presidential candidate for each party.

Tuesday, August 11 - Partisan Primary (if necessary) - primary held the second Tuesday in August to nominate candidates to be voted for at the general election and referenda (if necessary).

Tuesday, November 3 - General Election/Gubernatorial - election held in even-numbered years on the Tuesday after the first Monday in November to elect the President and Vice President of the United States (in Presidential years), United States Senator, Representative in Congress, State Senator, Representative to the Assembly, District Attorney, County Partisan Offices, and referenda (if necessary).

Wisconsin State Dog Law: (From Chapter 174 Wis. Stats). All dogs over 5 months old must have and wear a license and have a valid rabies vaccination. Proof of rabies vaccination must be sent with this form. A veterinarian must perform the vaccination.

Dog License cannot be issued by State law if proof of rabies vaccination is not sent along with this form.

Cost: **Male/Female: \$15.00 per dog**

Neutered Male/Spayed Female: \$10.00 per dog

Penalty after April 1st is \$5.00 per dog.

Recycling/Sanitation Center is located at N6285 Berlin Road, Green Lake, WI 54941 **for Town of Brooklyn residents ONLY.**

NOTE: Businesses are required by law to have their own dumpsters and are not allowed to use the Town Recycling/Sanitation/Green Waste Center (R/S/W).

You need to have a Town of Brooklyn sticker for your vehicle. Please see one of the attendants at the Center if you do not have one or if you have changed vehicles. Please bring proof of residence in order to receive a sticker.

Items collected at the Center that must be recycled

- Containers (aluminum, glass, plastic and steel)
- Paper/fiber products (newspapers, corrugated cardboard, magazines. *Items do not have to be separated- they are co-mingled.*)

IMPORTANT: PLEASE make sure containers are rinsed. ANY containers containing food, CANNOT BE RECYCLED and are considered waste.

Items considered waste and are not to be recycled

Electronics/Appliances with refrigerant	Plastic Bags/Wrap	Styrofoam
Motor oil bottles	Tissue paper	Pet food bags
Window glass	Ceramics or china	Drinking glasses
Aluminum pans or foil	Empty paint cans	Scrap metal

Compost - Only brush, grass clippings and leaves will be allowed in the collection area. No lumber is allowed. If you bring anything in bags, they have to be emptied into the collection area.

Scrap Lumber - Scrap lumber should be kept to a maximum of 4 feet long.

Green Waste - Please follow the new signage at the collection site.

We DO NOT collect the following items

- Lead acid batteries (old ones should be returned to the place you purchased the new one)
- Fluorescent bulbs
- Major appliances that contain refrigerants and any electronics as they contain heavy metals. The place you purchase these items should take them or may charge a small fee to recycle them.
- Used tires
- Used oil, oil filters, or any absorbents contaminated with oil
- No items which contain asbestos.
