## **BUILDING PERMITS ARE REQUIRED**

- ▶ All new buildings.
- ▶ All additions, remodelings or improvements. (Shingle replacements are exempt.)
- ▶ Driveway/culvert-new/alterd-33'/Town Right of Way-Only asphalt/gravel, no above ground obstacles

State Statute: The Wisconsin Uniform Dwelling Code protects the health, safety, and value of residential properties.

Town Ordinance: The Town building permit records property changes that do not require a State inspection.

Non Compliance will subject the property owner to a fine.

*All dogs over five months old must have and wear a license and have a valid rabies vaccination.*

**Failure to license or vacinnate your dog may result in a \$150 fine per dog by Green Lake Co.**
