2025 PROPERTY TAXES

1st Installment Tax Payments or payments in full

- Payment is due no later than January 31st, 2026. "First installment" or "Payment in full" will be by mail only.
- No in-person payment method will be available.
- If you would like a receipt, please include a self-addressed stamped envelope with your payment.
- Your payment must be postmarked by January 31, 2026. Your taxes will be deemed delinquent if postmarked after 1-31-2026.

2nd Installment Tax Payments

- Green Lake County Treasurer's office will **NOT** collect any taxes before February 2, 2026
- 2nd installment of taxes is due no later than July 31, 2026.
- Payment may be made in person, by mail or at drop box located in the vestibule of the Green Lake County Government Center. The drop box is accessible 24 hours a day, 7 days a week

DOG LICENSE APPLICATION AND INFORMATION

Wisconsin State Dog Law:

- All dogs over 5 months old must have a valid rabies vaccination and wear a license.
- No dog can be licensed without a current rabies certificate.
- A current rabies certificate must be submitted with your payment.
- Newly acquired dogs must be licensed within 30 days.
- Failure to obtain a dog license is subject to a citation from the Green Lake County Sheriff's Department

Licensing Private dogs

- Please complete the enclosed "Town of Manchester Dog License Form". List each dog separately with the requested information. A limit of 4 dogs may be licensed without a Kennel license.
- Provide a COPY of the current rabies certificate for EACH dog to be licensed
- Please include a separate check to cover all dog licensing. (If you are licensing dogs as well as paying taxes, a separate check is required for EACH bill.)
- Please provide a stamped, self-addressed envelope for return of licenses and receipt.
- If you own rental property, please notify your renters of dog licensing requirements.

Kennel Licenses

- The county requires that anyone with 5 or more dogs obtain a kennel license.
- An inspection of the kennel must be completed and successfully passed before tags can be issued.
- An inspection report and proof of vaccination for each dog must be submitted when applying for tags. Please provide a stamped, self-addressed envelope for return of licenses and receipt.
- Please contact the Tri-county Environmental Health Consortium to schedule an inspection. The telephone number is 920-294-4070.

Dog License Fees

- \$ 3.00 - neutered or spayed dog
- \$ 8.00 - dog not neutered or spayed
- \$35.00 - Kennel license: 5 to 12 dogs
\$ 3.00 - for each addition dog over 12 dogs

The Details

- All dogs must be licensed by April 1, 2026. Failure to do so will result in the dog being listed as unlicensed and records will be turned over to the county for enforcement..
- Payment for license will be returned if a current rabies certificate is not enclosed.
- Please send a COPY of the rabies certificate. We will NOT return original rabies certificates.
- Please complete and provide all requested information. COPIES ONLY.

2026 DOG LICENSE FEES

Neutered Male or Female: \$3.00/per dog. Non-Neutered Male or Female: \$8.00/per dog

2026 KENNEL LICENSE FEES

Owners with 5 or more dogs are required to purchase a kennel license. Cost for kennel license is \$35.00, up to 12 dogs. An additional \$3 fee per dog is required for more than 12 dogs

DOG/KENNEL LICENSE INSTRUCTIONS

Mail application, check payable to Town of Manchester, copy of rabies certification for each dog, and self-addressed stamped envelope to:

All dogs, over five months, are required to be licensed and vaccinated for rabies by March 31 of each year. A late fee of \$20.00 will be assessed for failure to obtain a dog license after March 31
