- **We will ONLY accept personal or bank certified checks. Please ensure that the written amount on the check matches the numerical amount. The bank will only process the payment based on the written amount.**
- Any returned checks for non-payment will be charged a \$35 handling fee.
- **Please include a telephone number on the check in case we need to contact you.**
- Enclose tear-off stub and a self-addressed stamped envelope if you want a receipt returned to you. If a self-addressed stamped envelope is not included, your cancelled check is your receipt.
- Send your payment postmarked by December 31, 2025, for 2025 credit.

In person payment:

- Payment can be made to Treasurer at the Town Hall, **by appointment only**.
- Payments received in 2026 will be dated as such. Taxes will not be considered paid until checks clear the bank.

CODE RED - KEEPING CITIZENS INFORMED

This program is through the Green Lake County Sheriff's Office. It is designed to get notifications out to residents by local emergency response teams, via your cell phone, in the event of an emergency or critical community alert, such as evacuations or notices of a missing child. BURNING PERMITS

In Green Lake County, burning permits are required from January 1 – May 31 – except when the ground is completely covered with snow.

When used appropriately, burning permits are an important tool in wildfire prevention. They allow the public to burn legal materials in the outdoors and are proven to be effective in protecting lives, property, and natural resources from the damages of unwanted wildfires.

The simple steps to being a responsible debris burner:

1. Obtain the annual burning permit online or by calling 1-888-WIS-BURN (947-2876) to have a permit mailed or instantly emailed.
2. On the day of the burn, check on the internet or over the phone after 11:00 a.m. for the daily fire restrictions in the county where you wish to burn.
3. Follow the rules for the day. Have tools and water available and make certain your fire is completely out before leaving.

Items **allowed** to burn: Brush, leaves, pine needles, grass, clean wood, unrecyclable paper and cardboard.

Items **NOT allowed**: Garbage, shingles, furniture, metal, vinyl products, plastic, foam, wire, aluminum, oil base products and rubber products.

DOG LICENSE APPLICATION --- PAYMENT IS DUE BY JANUARY 31st

Wisconsin State Dog Law: (From Chapter 174, Wis. Stats.) **All dogs over 5 months old must have and wear a license and have a valid rabies vaccination.**

The STATE LAW requires a current rabies certificate be submitted with your payment. By law, no dog can be licensed without it. If the rabies certificate cannot be found, contact the Vet that administered the vaccination and ask them to send you a copy of the certificate. Payment for license will be returned if a current rabies certificate is not enclosed and the dog will be listed as unlicensed, and information will be turned over to the County.

Failure to obtain a dog license is subject to a citation from the Green Lake County Sheriff's Department. The fine for an unlicensed dog is \$150.00/dog. The fine for an unvaccinated dog is \$150.00/dog. For your own protection, get your dog vaccinated and licensed. Homeowners, PLEASE pass this information along to your renters.

KENNEL LICENSES: The county requires that anyone with 5 or more dogs obtain a kennel license. An inspection of the kennel must be completed and passed before tags can be issued. An inspection report and proof of vaccination must be submitted when applying for tags. Please contact the Tri-County Environmental Health Consortium to schedule an inspection. The telephone number is 920-294-4070.
