## **DISCUSSION AND POSSIBLE ACTION REGARDING EDUCATION TRAILER**

The education trailer is already budgeted for between Land Conservation and Land Information. This trailer would be used for community events, field days and school events. Morris got quotes from I39 Graphics, Big O's Trailers and Badger Trailer. They are most interested in the trailer from I39 with a quote of \$11,850. This trailer has a Beavertail Ramp Door which makes it handicap assessable.

***Motion/second (Boutwell/Skivington)*** to allow Morris to move forward with purchasing the I39 trailer unless he gets a lower quote for another trailer that is handicap assessable. Motion carried with no negative vote.
