MINUTES

Motion/second (Buss/Schweder) to approve the minutes of the 02/11/2026 meeting as read with no errors or corrections. Motion carried with no negative vote.

HIGHWAY FACILITY BP3 APPROVALS

Highway Commissioner Derek Mashuda explained the bids. Recommendation was to go with Modern Overhead Door as company was the lowest qualified bidder.

Motion/second (Buss/Wielgosh) to accept the bid from Modern Overhead Doors for overhead doors in the amount of \$405,000. Motion carried with no negative vote.

Highway Commissioner Derek Mashuda explained the bids. Recommendation was to go with Metcon as company was the low bidder.

Motion/second (Buss/Schweder) to approve Metcon for the cold storage building in the amount of \$904,519.00. Motion carried with no negative vote.

Highway Commissioner Derek Mashuda explained the bids for the bridge crane. Recommendation was to go with Northwest Industrial Services.

Motion/second (Buss/Schweder) to approve Northwest Industrial Services for the crane in the amount of \$122,881.00. Motion carried with no negative vote.

Highway Commissioner Derek Mashuda explained the bids for the wells. Recommendation was to go with Sams Well Drilling. Discussion held.

Motion/second (Buss/Schweder) to approve Sams Well Drilling for the crane in the amount of \$49,470.00. Motion carried with no negative vote.

2026 MATERIALS BID APPROVALS

Highway Commissioner Derek Mashuda went through each bid request per road project. The recommendation was to go with Kartechner based on bid specifications for road projects, CTH N, CTH O, and CTH H for asphalt and laying.

Motion/second (Buss/Wielgosh) to approve Kartechner for asphalt and laying on CTH N, CTH O and CTH H road projects. Motion carried with no negative vote.

Highway Commissioner Derek Mashuda reviewed the aggregate bids for CTH N, CTH O and CTH H road projects. The recommendation was to go with Egbert Excavating for both CTH N and CTH O, and Kopplin & Kinas for road project CTH H.

Motion/second (Buss/Schweder) to approve the recommendations and use Egbert Excavating for CTH N and CTH O aggregate and Kopplin & Kinas for CTH H aggregate. Motion carried with no negative vote.

Highway Commissioner Derek Mashuda reviewed the bids for road oil for the year's projects. Recommendation was to go with Fahrner/Flint Hills for road oil.

Motion/second (Schweder/Reabe) to approve the recommendation and use Fahrner/Flint Hills for chip sealing in 2026. Motion carried with no negative vote.

HIGHWAY FACILITY UPDATE

PCI0009

Highway Commissioner Derek Mashuda explained the change order to make the HVAC system cohesive with the main County building.

PCI0012

Highway Commissioner Derek Mashuda explained the rejection of this and would be removing the \$55,230 from the total cost of the project.

PCI0010

Highway Commissioner Derek Mashuda explained the plumbing change to stainless steel for \$8,966.00.

Highway Commissioner Derek Mashuda gave an update on the progress of the new highway building construction. Stated that currently the building is slated to be finished at the beginning of December 2026. Discussion was held on fitting the interior with items not in the building specifications.

Discussion held on the use of old highway grounds. Will be brought back closer to the completion of the new building.
