ORDINANCE NO. -2026

Ordinance Amending County Code Article V, Medical Examiner, §§ 60-30, 60-31, 60-32 & 60-33

The County Board of Supervisors of Green Lake County, Green Lake Wisconsin, duly assembled at its regular meeting begun on the 16th day of June, 2026, does ordain as follows:

1 NOW, THEREFORE, BE IT ORDAINED, that §§ 60-30, 60-31, 60-32, & 60-33 shall be  
2 amended as follows:

4 **§ 60-30 Medical Examiner system created.**

5  
6 There is created an Office of the County Medical Examiner and the elective office of  
7 Coroner is hereby abolished effective upon the termination of the current term of the  
8 Green Lake County Coroner at midnight on January 1, 2023. Furthermore, effective  
9 June 1, 2026, Green Lake and Waushara Counties will enter into an Agreement  
10 whereby Waushara County will provide medical examiner services for Green Lake  
11 County.

13 **§ 60-31 Appointment.**

14  
15 The Green Lake Waushara County Board shall appoint the Medical Examiner. The  
16 County Administrator shall supervise the Medical Examiner. The Medical Examiner shall  
17 be subject to the Intergovernmental Agreement for Medical Examiner Services entered  
18 into by both Counties.
